

DIST Sir,

In producing here with the following arrested accused persons namely (i) Sishupal Nayak (27 yrs) S/O Ananda Nayak of Vill-Mohanpur, PS- Kotshila, Dist- Purulia, (ii) Pradip Singh Mura (19 yrs) S/O Bhajan Singh Mura of Vill- Pandra, P.S. Kotshila, Dist. Purulia and brought under seizure 02(two) seized Tractors- (i)WB55B/1695, (ii) WB55B/2322 both are attached with a sand loaded trolley. The fact in brief is that today (06.09.2020) evening at about 17:45 hrs received a credible source information that few tractors were carrying sand illegally and coming from Tulin ghat & going towards Jhalda side. Accordingly, myself along with force left PS to work out the said source information. This refers to Jhalda PS GDE No- 188 Dated- 06/09/2020 & Jhalda PS CC No- 2579 Dated- 06/09/2020. Then, we intercept the said vehicles near Birsha more on Purulia Ranchi road under Jhalda PS at about 18:25 hrs and found the above noted tractors were tagged with a trolley each loaded with sand. On asked, the drivers disclosed their identity as mentioned earlier. On demand, all of them failed to produce any valid papers in respect of the Tractors and attached Trolley as well as loaded sand though sufficient time was given. During interrogation, the drivers of the said tractors confessed that they in convince with the respective owners of said seized Tractors & others are doing illegal business of sand. They have no paper / challan for loaded sand. Then, I ASI Habibul Rahaman Mandal arrested the following accused drivers of said vehicles (as disclosed during interrogation)- (i) Sishupal Nayak (driver of the tractor Mahindra WB55B/1695) S/O Ananda Nayak of Vill-Mohanpur, PS- Kotshila, Dist- Purulia, (ii) Pradip Singh Mura (driver of the tractor WB55B/2322 S/O Bhajan Singh Mura of Vill- Pandra, P.S. Kotshila, Dist. Purulia under proper arrest memo and also seized the Tractors (i)WB55B/1695, (ii) WB55B/2322 with attached sand loaded Trolley(approx 100 cft) each.

On return to P.S., Put the arrested accused persons into the P.S. Lock UP after maintaining all formalities, kept the sand loaded seized vehicles at PS compound and I do here by submitting written complaint before you to start a cog case against (i) Sishupal Nayak (27 yrs) S/O Ananda Nayak of Vill-Mohanpur, PS- Kotshila, Dist- Purulia, (ii) Pradip Singh Mura (19 yrs) S/O Bhajan Singh Mura of Vill- Pandra, P.S. Kotshila, Dist. Purulia, (iii) Owner of the Tractor WB55B/1695, (iv) Owner of the Tractor WB55B/2322 & others under proper section of law.
