In producing here with one arrested accd. Person namely Saharai Orang (50 yrs) S/O Lt. Haladhar Orang of Vill- Ranigora, P.S- Jhalda, Dist- Purulia brought under seizure 02 (two) plastic Jaricans containing approx 08 (eight) Ltrs. ID liquor in each Jarican, total 16 (Sixteen) ltrs. ID liquor from his possession. I do hereby lodged this written complain to the effect that on-07/09/20 at 18:05 hrs. I received telephonic source information that one person selling (Country sprit) at Ranigora Village. I inform the matter to I/C Jhalda P.S over Phone as per his direction myself ASI- Dulal Singha Sardar, along with C/696-Gorapada Pal, C/611- Jitendranath Pathak, vide C.C No. 2589/20 dtd- 07/09/20 left for Ranigora village to work out the information. We reached at Ranigora village at about 19:05 Hours and held raid in the house of Saharai Orang (50 yrs) S/O Lt. Haladhar Orang of Vill- Ranigora, P.S- Jhalda, Dist- Purulia, and found that the accused person selling ID liquor from his house. Seeing the Police party the buyers are fled away. On demand he could not produce any valid documents/license in favour of selling the same. Accordingly I seized 02 (two) plastic Jaricans containing approx 08 (eight) Ltrs. ID liquor in each Jarican, total 16 (Sixteen) ltrs. ID liquor under proper seizure list duly signed by the witnesses as well as accused person with proper label. I search for local witnesses but found none.

Accordingly I arrested accd. Saharai Orang (50 yrs) S/O Lt. Haladhar Orang of Vill-Ranigora, P.S- Jhalda, Dist- Purulia maintaining all formalities after issuing arrest memo. On integration he confessed that he is selling the said ID liquor to the villagers in lieu of money. So he committed offence punishable U/S – 46 (A) (c) of B.E. Act. 1909.

On return to P.S. along with accd. person and all seized articles. Put the accd. person in the Lock Up after maintaining all formalities and seized articles kept in P.S. Malkhana and I do here by submitting written complaint before I/C Jhalda P.S. to start a case against Saharai Orang (50 yrs) S/O Lt. Haladhar Orang of Vill- Ranigora, P.S- Jhalda, Dist-Purulia under proper section of law.
