Sir,

In producing here with 02 (two) arrested accd. persons namely (i) Anadi Mahato (43) S/O Lt. Banamali Mahato of vill- Darda, PS-Jhalda, Dist-Purulia and (ii) Lakhiram Lohar (58) S/O Lt. Bibhuti Lohar of vill- Khamar, P.S- Jhalda, Dist- Purulia brought under seizure 02 (two) plastic Jaricans containing 15 (Fifteen) Ltrs. ID Liquor in each jarican total approx 30 (Thirty) Ltrs. ID liquor from their possession. I do hereby lodged this written complain to the effect that on-26/09/20 at 18:05 hrs. I received telephonic source information that above noted persons selling ID Liquor at Darda Village. I inform the matter to I/C Jhalda P.S over Phone as per his direction myself ASI- Sk. Abdul Jamshed along with C/696- Gorapada Pal, C/386 Sibendhu Sinha vide C.C No. 2747/20 dtd- 26/09/20 left for Darda village to work out the information. We reached at Darda village at about 18:35 hrs and held raid in the house of Anadi Mahato (43) S/O Lt. Banamali Mahato of vill- Darda, PS-Jhalda, Dist-Purulia and found that he along with Lakhiram Lohar (58) S/O Lt. Bibhuti Lohar of vill- Khamar, P.S- Jhalda, Dist- Purulia are selling ID liquor from his house. Seeing the Police party the buyers are fled away. On demand they could not produce any valid documents/license in favour of selling the same. Accordingly I seized 02 (two) plastic Jaricans containing 15 (Fifteen) Ltrs. ID Liquor in each jarican total approx 30 (Thirty) Ltrs. ID liquor under proper seizure list duly signed by the witnesses as well as accused persons with proper label. I search for local witnesses but found none.

Accordingly I arrested accd. persons namely (i) Anadi Mahato (43) S/O Lt. Banamali Mahato of vill- Darda, PS-Jhalda, Dist-Purulia and (ii) Lakhiram Lohar (58) S/O Lt. Bibhuti Lohar of vill- Khamar, P.S- Jhalda, Dist- Purulia maintaining all formalities after issuing arrest memo. On integration they confessed that they are jointly doing this illegal business and selling the said ID liquor to the villagers in lieu of money. So they committed offence punishable U/S – 46 (A) (c) of B.E. Act. 1909.

On return to P.S. along with accd. persons and all seized articles. Put the accd. persons in the Lock Up after maintaining all formalities and seized articles kept in P.S. Malkhana and I do here by submitting this written complaint to start a case against (i) Anadi Mahato (43) S/O Lt. Banamali Mahato of vill- Darda, PS-Jhalda, Dist-Purulia and (ii) Lakhiram Lohar (58) S/O Lt. Bibhuti Lohar of vill- Khamar, P.S- Jhalda, Dist- Purulia under proper section of law.
