In producing herewith the following arrested accd. persons (i) Bijoy Kumar Mahato (23) S/O Jyotindranath Mahato of vill- Merend, PO-Mahatomara, PS-Jhalda, Dist-Purulia (ii) Dwijapada Mahato (27) S/O Trilochan Mahato of vill-Dumurdih, PO-Mahatomara, PS-Jhalda, Dist-Purulia (iii) Hemanta @ Bhutu Mura (19) S/O Shyamchand Mura of Do and brought under seizure the following articles- 1. One fully iron made Vojali (Knife) length approx 06'' (six) inch in which butt 2'' (two inch), 2. One fully iron made Vojali (Knife) length approx 07'' (Seven) inch in which butt 2'' (two inch), 3. 02 (two) pieces iron rod length approx 03'' (three feet), 4. 05 (five) pieces bamboo stick (Lathi) length approx 04'' (four feet), 5. 04 (Four) pieces torch light (plastic body), 6. One nylen rope length approx 20'' (Twenty) meter after preparing a seizure list duly signed by the witnesses as well as accd. persons. I, ASI Dulal Singh Sardar do hereby lodge this written complaint against the above noted accd. persons and (i) Mrithilesh Mahato S/O Rabi Mahato of vill-Dumurdih, PO-Mahatomara, PS-Jhalda, Dist-Purulia (ii) Rajib Mahato S/O Ajit Mahato of Do (iii) Chandan Kuiry of Jhalda Ward No-11, PS-Jhalda, Dist-Purulia (iv) Rakesh Kuiry of Do and 08/10 others to the effect that on 27/09/20 at 22:25 hrs received a telephonic information from my source during evening Mobile duty at Binsha more under Jhalda P.S. vide Jhalda P.S. C.C. No- 2752/20 Dt- 27/09/20 that 15/16 criminals assembled in a bush area near Kansra village with a view to commit Road dacoity on Jhalda Gola Main road at Kansra Area. After getting such type of information I informed the matter to I/C Jhalda P.S. and as per his direction myself along with accompany force C/386 Sibendhu Sinha, NVF/877 Samir Kr. Mahato, NVF/843 Bibekananda Mahato proceeded towards Kansra to work-out the said information with Govt. Vehicle No-WB 56C/8741. When myself along with accompanied force reached near Kansra village on Jhalda Gola road on 27/09/2020 at 23:05 hrs. and stop the vehicle by the side of the road and proceeded towards the bush area near Kansra village as informed by my source on foot and when we reached very near to the spot and found 15/16 persons sitting in a bush area, dark place and whispering each and others. We tried to apprehend them but seeing the police party they tried to flee away but on hot chase we able to apprehend the above noted 03 (Three) accd. persons. On immediate search on their person, one fully iron made Vojali (Knife) length approx 06'' (Six) inch in which butt 2'' (two inch) from the possession of Bijoy Kumar Mahato, one fully iron made Vojali (Knife) length approx 07'' (Seven) inch in which butt 2'' (two inch) from the possession of Dwijapada Mahato, 01 (One) iron rod length approx 03'' (three feet) from the possession of Hemanta @ Bhutu Mura. During search at P.O. I also found 01 (One) iron rod length approx 03'' (three feet), 05 (five) pieces bamboo stick (Lathi) length approx 04'' (four feet), 04 (Four) pieces torch light (plastic body), and One nylen rope length approx 20'' (Twenty) meter. On being asked they disclosed their identity as noted above but they could not give any satisfactory reason for keeping the Vojali and other weapons and to assemble that place at the dead hour of night. On interrogation they disclosed that they along with (i) Mrithilesh Mahato S/O Rabi Mahato of vill-Dumurdih, PO-Mahatomara, PS-Jhalda, Dist-Purulia (ii) Rajib Mahato S/O Ajit Mahato of Do (iii) Chandan Kuiry of Jhalda Ward No-11, PS-Jhalda, Dist-Purulia (iv) Rakesh Kuiry of Do and 08/10 others who were there but they fled away on getting the scent of police, were assembled there and preparing to commit road dacoity in any vehicle on Jhalda Gola road near Kansra village.

So, I arrested 03 (Three) accd. persons after preparing arrest memos and seized the all above noted articles under proper seizure list duly signed by witnesses as well as the accd. persons. Due to mid night hours no public witnesses was available there.

So I, therefore, lodge a complaint against accd. persons namely (i) Bijoy Kumar Mahato (23) S/O Jyotindranath Mahato of vill- Merend, PO-Mahatomara, PS-Jhalda, Dist-Purulia (ii) Dwijapada Mahato (27) S/O Trilochan Mahato of vill-Dumurdih, PO-Mahatomara, PS-Jhalda, Dist-Purulia (iii) Hemanta @ Bhutu Mura (19) S/O Shyamchand Mura of Do (iv) Mrithilesh Mahato S/O Rabi Mahato of Do (v) Rajib Mahato S/O Ajit Mahato of Do (vi) Chandan Kuiry of Jhalda Ward No-11, PS-Jhalda, Dist-Purulia (vii) Rakesh Kuiry of Do and 08/10 others for committing the offence U/S- 399/402 IPC.
