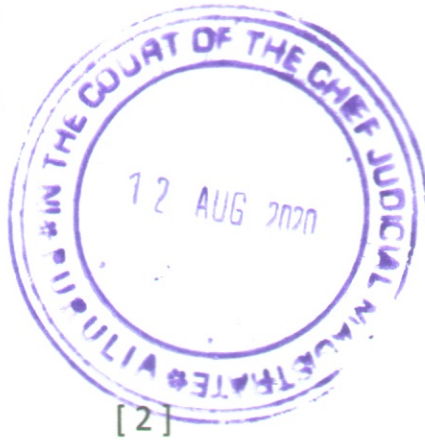

30.07.2020 at about 7:00 A.M. Over R.S. Plot No. 1172 of Mouza-Dimdiha, Under P.S. Joypur.

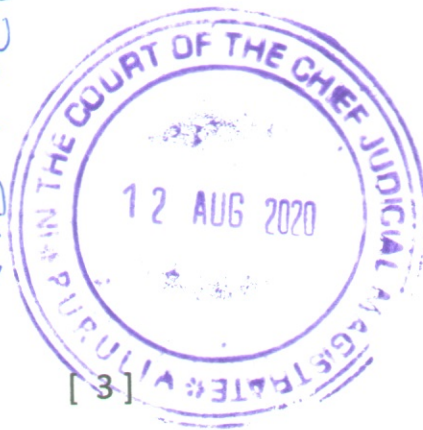
Complainant above named beg to state as follows:-

- 1) That the complainant and his other co-sharer are the owner, possessor and title holder in respect of the R.S. Plot No. 1172 of Mouza- Dimdiha, Under P.S. Joypur.
- 2) That the predecessors of the complainant transplanted some trees such as Dhela, Nim etc. over R.S. Plot No. 1172.
- 3) That after demise of predecessors of the complainant the complainant and his brothers are enjoying the said trees.
- 4) That on 30/07/2020 at about 07:00 A.M. all the accused persons are came into the spot with Axe, Lathi, Knife, Iron-rod, etc and cut the trees and fallen down over the field, and Witnesses No.4 went to the spot and raised objection but all the accused persons are giving out threats to the Witnesses No.4 if he come on spot then they will murder to the Witnesses No.4. At that time Witnesses No.4 informed over telephone to the complainant then Complainant also came to the spot at that time accused persons No.1 assault to the complainant by fist and blow and openly say that I.C. Joypur Police Station gave ordered to the accused persons are to cut the trees and may sold to other persons.

- 5) That there-after the complainant went to the Office of I.C. Joypur Police Station and also I.C. Joypur Police Station threats to the complainant that if he come into spot then they will arrested to the complainant and his family members.
- 6) That the complainant was soft and came back of his house and come to learn that some trees was already sold to other persons and some trees was fallen down on spot till now, and the Accused Persons are also openly given out threats to the complainant and his family members that if the complainant lodged any complain before any Concern Authority then they will filed case against the complainant and his family members.
- 7) That the complainant substance loss sum of Rs. 25,000/- (Rupees Twenty Five thousand only).
- 8) That the Complainant submits, that all the accused persons have no right to cut the trees over R.S. Plot No. 1177.
- 9) That the witnesses are saw the occurrence.

It is prayed, that your Honour would be pleased to admit the case and sent this said petition to I.C. Joypur P.S. and directed him to treated the petition as F.I.R. and also pass necessary order which will deemed fit and proper.
