Sir.

In producing herewith 02 (two) Tractors having Regd. No-WB55A-9706 & WB55A-7450 with loaded sand under proper seizure list. The fact of the case in brief is that on 11/09/2020, 1 along with force (1) JC/-282 Amit Ghosh (2) JC/-725 Rahul SM Patra both of Joypur P.S were on Day Mobile duty vide Joypur PS CC No-3579/20 date-11/09/2020. During mobile duty on 11/09/2020 at about 13:05 hrs under direct Supervision of SDPO Jhalda & IC Joypur PS conducted raid at Kahan on the Bank of River Kansai. Found that the above noted Tractors were present at Kahan on the Bank River of Kansai loaded with sand. On seeing the Police party the drivers of the said Tractors stopped their Tractors at Kansai river and fled away. We rushed to the Tractors and detained at 13:45 hrs. We searched the said Tractors and found that the Tractors are loaded with sand and also searched surrounding P.O but I did not trace out the said offending Tractors driver. Hence I seized the 02 (two) Tractors having Regd. No-WB55A-9706 & WB55A-7450 with loaded sand under proper seizure list in presence of available witnesses duly signed by the witnesses and I brought the said Tractors to Joypur P.S. As such there is every reason to believe that the driver and owner of the said Tractors with ill motive are transporting the sand illegally without any valid document in support of carrying sand & violating the Lockdown order. Lockdown is going on throughout the state of W.B in view of Pandemic of COVID-19 outhreak and violating the Govt, order they are doing such illegal activity. So they are liable for offence punishable U/S- 188/379/411/414 IPC & 21 (1) (4) Mines and Minerals (R&D) Act-1957

Therefore, I pray before you that a case against the driver and owner of the said Tractors may kindly be started and arrange for its investigation.
