Sir,

In producing herewith seized the 01 (one) Tractor (Engine) along with trolley having Regd. No-WB55A-3718 loaded with sand under proper seizure list. Today (13/09/2020) I along with (1) JC/-426 Biswajit Banik (2) JC/-282 Amit Ghosh both of Joypur P.S were on Special Mobile duty vide Joypur PS CC No-3604/20 Date-13/09/2020. During mobile duty at about 12:25 hrs under direct Supervision of IC Joypur PS conducted raid at Jahajpur on the Bank of River Kansai and found that the above noted Tractor was present at Jahajpur on the Bank of River Kansai loaded with sand. On seeing the Police party the driver of the said Tractor fled away leaving the Tractor loaded with sand. We detained the Tractor at 12:25 hrs and also searched surrounding of Jahajpur river ghat but I did not trace out the driver of said Tractor. Hence I seized the Tractor (Engine) along with trolley loaded with sand under proper seizure list in presence of available witnesses duly signed by the witnesses. I brought the said Tractor to Joypur P.S. The said driver and owner are habitually dealing with illegal sand lifting & transporting business violating the Govt. Notification / Order. As such there is very reason to believe that the driver and owner of the said Tractor are lifting & transporting the sand from riverbed with ill motive and illegally without any valid document in support of carrying sand and also violating the order notification vide DM Purulia Memo No-VI/430(Part-VIII)/1176/M/90/M/17 Dated-26/06/2020. Regarding ban of sand lifting from riverbed.

Hence they are liable for offence punishable U/S- 188/379/411/414 IPC & 21 (1) (4) Mines and Minerals (R&D) Act-1957.

Therefore, I pray before you that a case against the driver and owner of the said Tractor may kindly be started and arrange for its investigation.
