In producing here with one arrested accused namely Raban Garain (29Yrs) S/O Balaram Garain of Karkara D Para, PS- Joypur, Dist- Purulia along with following seized articles viz- 1) 12 bottles of "Dil Se" Country Spirit strength 80 up each 600ml, (MRP Rs-

60/-) 2) Plastic Glass- 30 Pcs.

I, ASI Surendranath Soren of Baglata I/C under Joypur P.S. do here by lodged a complaint against arrested accd. Person namely Raban Garain (29Yrs) S/O Balaram Garain of Karkara D Para, PS- Joypur, Dist- Purulia to the effect that on 19.09.20 at about 17.25 hrs in course of my day mobile duty vide Baglata IC CC No 1803 dt- 19.09.20 received a telephonic information from a reliable source that one Raban Garain (29Yrs) S/O Balaram Garain of Karkara D Para, PS- Joypur, Dist- Purulia was stocked ID liquor illegally and selling the same to price for his personal gain then. I informed O/C Baglata IC under Joypur PS and as per order of O/C Baglata I/C myself along with C/522 Ruplal Tudu, C/530 Shankar Mahato all of Baglata IC rushed to the spot for raid by Govt. vehicle. At about 18.15 hrs myself along with force reached at Karkara D Para and held raid in his house of said Raban Garain S/O Balaram Garain of Karkara D Para, found 12 bottles of "Dil Se" Country Spirit strength 80 up each 600ml, (MRP Rs- 60/-) at his counter at Karkara D Para for selling in high price without having any valid paper against the said country spirit as I asked for. Seeing Police party Raban Garain S/O Balaram Garain of Karkara D Para, PS- Joypur, Dist- Purulia try to conceal himself but we are able to apprehend him and also detained him and also seized the said 1) 12 bottles of "Dil Se" Country Spirit strength 80 up each 600ml, MRP - Rs- 60/2) Plastic Glass- 30 Pcs after preparing proper seizure list. So he arrested the above mentioned accused person u/s 46 A(c) BE Act informing the ground of arrest and also made label duly sign by accd. person by available witnesses. I also made check list of him.

Hence I there for pray that a specific case may kindly be started against arrested accd. Raban Garain (29Yrs) S/O Balaram Garain of Karkara D Para, PS- Joypur, Dist- Purulia and

arrange for its investigation.
