Persons namely (i) Bhakta Goswami ( 34), S/o- Bhisma Goswami of Vill- Kurmasole , PS- Kenda, Dist- Purulia (ii) Nirmal Ch. Mahato (43)S/o- Rakhil Ch. Mahato of Vill- Bansa , PS- Kenda, Dist- Purulia do hereby lodge a written complaint against them to the effect that today on 31/08/2020, as per direction while I along with C/1492 Dlip Ch. Gorain & C/1572 Badal Mahapatra both of Kenda PS engaged in special mobile duty at Kenda PS area for implementation of Government rules regarding Lockdown Disaster Management Plan. While we reached at Kenda Sardardih more at about 16.35 hrs. found that the above noted persons along with others moving here and there without wearing of mask during this pandemic situation and not maintaining the social distancing and seeing the police parties some of them fled away and we are able to arrest the above noted accused persons, as there is every possibility that the above noted accused persons moving here and there without wearing a mask which violates the compliance of norms of wearing of mask during this pandemic situation and committed negligent act likely to spread infection of disease dangerous to human life and violated Government rule.

Therefore, I pray that a specific case may kindly be start against (i) Bhakta Goswami ( 34), S/o- Bhisma Goswami of Vill- Kurmasole , PS- Kenda, Dist- Purulia (ii) Nirmal Ch. Mahato (43) S/o- Rakhil Ch. Mahato of Vill- Bansa , PS- Kenda, Dist- Purulia do hereby lodge a written complaint against them to the effect that today on 31/08/2020, as per proper section of law.
