Subject: - Lodging FIR to the person for misappropriation the government money regarding Banglar Awaas Yojana housing scheme for the (FY 2019-20).

This is to inform you that Durjyodhan Kisku, S/o-Jogindranath Kisku, Vill-Kuruktopa, P.O-Kuruktopa, G.P-Pirrah is a sanctioned beneficiary of BAY for the (FY 2019-20) whose PMAY ID is WB5112625, account holder of Punjab National Bank, Kenda Branch. As per guideline of BAY alias PMAY-(G) housing scheme we had released the 1st installment amount Rs. 60,000/to that beneficiary through FTO mode which was credited on 16.10.2019, as reflected in the Awaas Soft system generated report, attached herewith.

On 20th November, 2019 an written information has been received from Gram Panchayat end, where it was mentioned that the installment which was released from the block end has not been credited to the sanctioned beneficiary. After receiving that without wasting any time that matter was investigated and found that the entire amount was being deposited into the account no. 1681001700060354 of Punjab National Bank, Kenda Branch i.e. belongs to Shyamapada Mahato, S/o-Gopal Mahato, VIII-Kenda, P.O-Balakdih, G.P-Kenda. It is also mention here that the account no. of Durjodhan Kisku (BAY Beneficiary) is 1681001700060345 and which was due to unintentional typing mistake to put the bank account details at the time of the registration of the beneficiary by Gram Panchayat level.

The bank authority has been informed for non-crediting of the money to that wrong account no., in written vide memo no. 2056/PB, dated-21/11/2019. The Branch Manager, Punjab National Bank, Kenda Branch replied that the released amount has already been credited into the account of Shyamapada Mahato and the total credited amount has already been withdrawn by him and thereby he made his PNB account ZERO. Due to that the Branch Manager has been failed to stop the money for crediting into that wrong account.

In this regard, we had scheduled a hearing for solving the matter on 19.02.2020 at the Block Office through the office letter vide memo no. 248/PB, dated-12.02.2020. During the hearing the Hearing Officer Joint Block Development Officer, Puncha Dev. Block asked to the Shyamapada Mahato for returning the government money which he was not entitled. But it was unfortunate that he replied he could not return the government money. This establishment also gave him a 7 (seven) days of timeline vide memo no.1216/PB, dated-15/07/2020 with addressing to Shri. Gopal Mahato who is the father of Shyamapada Mahato for returning the Government Money, but they failed and did not obey the instruction of the undersigned and any positive response has not been received till date from them. So, Gopal Mahato has also criminal conspiracy for breach of appropriation of Govt. money.

According to the above facts it is completely clear that Shyamapada Mahato intentionally withdrawn the government money and denying to return that. As a result of that the actual BAY beneficiary is being deprived. It is all about the case of money laundering and shown the indignity to the Block authority in terms of not returning the government money.

Therefore, these matters are considered as an offence and lodge a FIR under against minor accused Shyamapada Mahato, S/o-Gopal Mahato and his father Gopal Mahato S/o- Late. Lusu Mahato both are residence of Vill-Kenda, P.O-Balakdih, P.S-Kenda, Dist-Purulia under your jurisdiction.
