Aswini Roy Bhuiya of Vill- Ramakundi , PS- Puncha, Dist- Purulia (ii) Indrajit Murmu (19), S/o- Barka Murmu of Vill- Samakata , PS- Puncha, Dist- Purulia (iii) Sadhan Rajak (40) S/o- Hari Rajak of vill- Chipida, P.S - Tamna, Dist- Purulia do hereby lodge a written complaint against them to the effect that today on 07/09/2020, as per direction while I along with C/1182 Santosh Kr. Mahato & C/1157 Khaja Sams Basar both of Kenda PS engaged in special mobile duty at Kenda PS area for implementation of Government rules regarding Lockdown Disaster Management Plan. While we reached at Kenda Thana more at about 15.45 hrs. found that the above noted persons along with others moving here and there without wearing of mask during this pandemic situation and not maintaining the social distancing and seeing the police parties some of them fled away and we are able to arrest the above noted accused persons, as there is every possibility that the above noted accused persons moving here and there without wearing a mask which violates the compliance of norms of wearing of mask during this pandemic situation and committed negligent act likely to spread infection of disease dangerous to human life and violated Government rule.

Therefore, I pray that a specific case may kindly be start against (i) Bahadur Roy Bhuiya (50), S/o- Lt. Aswini Roy Bhuiya of Vill- Ramakundi , PS- Puncha, Dist- Purulia (ii) Indrajit Murmu (19), S/o- Barka Murmu of Vill- Samakata , PS- Puncha, Dist- Purulia (iii) Sadhan Rajak (40) S/o- Hari Rajak of vill- Chipida, P.S - Tamna, Dist- Purulia as per proper section of law.
