While we reached at Sardardih Morth at about 16.45 hrs. found that the above noted persons along with others moving here and there without wearing of mask during this pandemic situation and not maintaining the social distancing and seeing the police parties some of them fled away and we are able to arrest the above noted accused persons, as there is every possibility that the above noted accused persons moving here and there without wearing a mask which violates the compliance of norms of wearing of mask during this pandemic situation and committed negligent act likely to spread infection of disease dangerous to human life and violated Government rule.

Therefore, I pray that a specific case may kindly be start against (i) Niranjan Kisku (23), S/o- Shyamlal Kisku of Vill- Lohat , P.O- Kalidah, PS- Kashipur, Dist- Purulia (ii) Bidhan Soren (22), S/o- Haradhan Soren of Vill- Upar Panchmahali, PS- Kashipur, Dist- Purulia as per proper section of law.
