producing herewith one Tractor having Engine 3100FLU93A819166F18 and Chassis No. 10008636ED attached with Trolly loaded with sand without any number plate. The fact of the case in brief is that on 16/09/2020 Lalong with C/974 Dilip Kr. Ghosh and C/1255 Ajoy Kr. Bouri all of Kenda PS were on evening mobile duty. During mobile duty on 16/09/20 at about 19.35 hrs. under direct supervision of CI Manbazar Circle conducted raid near at Chandatiri village on the bank of river Kansai and found that above noted tractor was present near at Chandatiri village on the bank of river Kansai. On seeing the Police party the driver of the said tractor stopped the tractor in a distance and fled away after keeping the tractor near at Chandatiri village. We searched the said tractor and found that the tractor was loaded with sand. Hence we waited there some times and held an enquiry about the said tractor but none turned up and demanded as actual owner of the said tractor or the sand and ascertained that the owner and driver of the said tractor loaded the said sand by illegal manner for selling the same to make profit by dishonestly in a clandestine business. So seized the tractor having Engine No. 3100FLC93 \819166F18 and Chassis No. 10008636ED attached with Trolly loaded with sand without any number plate under proper seizure list in presence of available witnesses duly signed by them. Thereafter arranging a driver from my source and brought the said tractor to Kenda PS. So it reason to belief that driver & owner of the said tractor procured the said sand by fraudulently means or theft by any means for transporting the same to clandestine business.

Under the above facts and circumstances kindly take lawful action against the owner and driver of the Tractor having Engine No. 3100FLU93A819166F18 and Chassis No. 10008636ED attached with Trolly loaded with sand.
