





The Complainant above named begs to state as follows:


- 1. That the Complainant is a resident of Village Bararala, within P.S. Kotshila.
- 2. That Rampada Kumar has also his Khamar and house over R.S. Plot/L.R. Plot No.s. 951 and 950 at Mouza Taherbera. The said L.S. Plot No. 951 stands recorded in the name of Rampada Kumar, Village Taherbera is at a distance of ½ K.M. from Village Bararela.
- 3. That Rampada Kumar enclosed Plot No's. 950 and 951 by raising wall and also Made Tulse Mancha over R.S. Plot No. 950. Both theplots have been amalgamated with each other.
- That the complainant has also rabsed construction over R.S. Plot No. 950. In the Khamar the complainant and his father have stacked straw, 12000 boundles which is valued at Rs.30,000/- to 40,000/-.



- 5. That the complainant has also his house over R.S. Plot NO. 949 which has been recorded in the name of the Complainant. The said R.S. Plot No's. 949 and 950 are contiguous to each other.
- 6. That witness No's. 2 and 3 also stay in the house situated over R.S. Plot No. 949.
- 7. That the Accused persons are residents of Village Taherbera. They belong to same family and the Accused persons are barbouring grudge and animosity against the Complainant and his family members as the Complainant has purchased R.S. Plot No.s. 950 and 951 from the co-sharer of Paritosh Saha Babu.
- openly gave out that they will not allow the Complainant's party to stay at Village Taherbera and/or to raise any house and they will murder the complainant and his father Rampada.
- 9. That on 6.2.2020 at about 7.30 A.M. the Accused persons by forming an unlawful assembly criminate and selection of the Land Showel and set fire in the land set fire in the la



straw, kept in the aforesaid poots and the Accused persons also damaged the wooded door of the rooms situate over R.S. Plot No. 951 and set fire over it.

- 10. That witness No's. 2 and 3 who are residing in R.S. Plot No. 949 immediately came and say the incident about setting of fire in the wooden door and the straw and the wooden costs inside the room. The Accused persons brought Kerosene in two pots and sprinkle over it and they stated in loud voice in presence of witness No's. 2 and 3 that they will kill the every inmates in the house.
- Purulia in a train with Banka Behari Das. The Complainant through Cello phone received the news and he tried to contact with Officer_in_charge Kotshila P.S..
- 12. That the complainant lodged diary on 8.2.2020 at Kotshila P.S? but the Police did not m take any action. Written information was sent by Registered Post. THE Complainant also on 3.3.2020 sent information to the Superintendent of Police, Purulia by Registered Post with Ack-due.
- 13. That the complainant has sustained loss of contd..p. 5.



Rs.30,000/- to 40,000/- due to setting fire of straw and wooden articles.

- 14. That the accused persons are still roaming in the village though they have committed offence Under Section 447/ 436/ 506 I.P.C.
- persons and no body is coming forward to give witness against the accused persons. Furthermore due to Covid—19 the Complainant could not come to Purulia to or to file the case, though he was assured by the Officer—in—charge Kotshila P.S. that due to lock down signation they could not go to spot for enquiry.
- 16. That the Accused persons have committed offence
