Sir,

In producing here with 07(Seven) arrested accused persons namely 1) Rabindranath Hembrao (21) S/O Motilal Hembrao of village - Barogajati, PS - Manbazar District Purulia 2) Basanta Mandi (23) S/O Ramdhan Mandi of village- Jyotishnud , PS Kenda District Purulia 3) Sejti Mandi (21) S/O Lt Ananda Maesi of village Jyotishnud , PS Kenda District Purulia 4) Sukumar Murmu (20) S/O Malindra Murmu of village- Damdohi, PS Punccha District Purulia 5) Swapna Mahato (21) S/O Santosh Mahato of village Kumari, PS Boro, District Purulia 6) Krishnapada Mahato (31) S/O Lt Narugopal Mahato of village Kumari, PS Boro, District Purulia 7) Gonesh Chandra Mahato (32) S/O Lt Trilochan Mahato village Kumari, PS Boro, District Purulia along with seized motor Cycle , seizure list, memo of arrest, Inspection Memo & other relevant papers.

I beg to state that today (31.08.20), I was directed to find out whether the lock down has been implanted properly at Manbazar PS area or not. This refers to Manbazar PS GDE No- 1209, Dtd 31.08.20. Accordingly, I had been to Daldaria village more at about- 16-45 hrs I found that the above noted persons with their Motor Cycle, were roaming aimlessly at Daldaria village more. Myself and ASI Prasanta Mandal & along with force detained them at Daldaria village more road under Manbazar PS. On being asked the above accused persons could not able to give any satisfactory answer for that movement on road and public place. Though lockdown is going on throughout the District of Purulia in view of Pandemic of COVID-19 outbreak vide Govt. of India consolidated order No-40-3/2020-DM-1 (A) Date-24/03/2020 and further modified dated-25/03/2020, 27/03/2020, 02/04/2020, 03/04/2020 & 10/04/2020 for complete restriction measure. As such the above persons violated the order during this pandemic situation duly promulgated by Govt. of West Bengal vide Order No- H & F W/120/20 dated 22.03.2020 which is extended till now. Moreover all the detained persons were refuses to comply the direction given by the Central Govt. & State Govt. to combat the severity of COVID-19 pandemic. All the accused persons also tried negligently to spare infection of disease dangerous to life.

I arrested them for Disobedience to order duly promulgated by public servant; after maintaining all rules of arrest, Issued memo of arrest & Inspection Memo, I informed them & their relatives regarding the ground of arrest i.e, as per section 3 of the Epidemic Diseases Act, 1897, provide penalties for disobeying any regulation or order made under the Act. These are according to Section 188 of the Indian Penal Code (Disobedience to order duly promulgated by public servant). At prima facie there were sufficient evidences to secure their detention. Moreover they driven the motor cycle on public way in rush and negligently as to endanger to human life. On being asked they did not produce the valid documents in respect of said motor cycle as well as driving license.

I seized One pulsar (Blue & Black Colour) motor cycle Bearing registration no- WH 56Q/4785 vide Chassis no- MD2A92CYOKCG-28114 and Engine No- JEYCKG46876 driven
