Sir,

In producing here with one accused person Ramdhan Gope (38) S/O Lt- Shyamapada Gope of village- Patharkata. PS- Manbazar. Dist- Purulia along with following seized articles viz-

- (1) 28 (Twenty Eight) Ltrs. Country Sprit contained in a Plastic container.
- (2) 06 pieces plastic glass

I ASI Aniruddha Chatterjee of Manbazar PS do here by lodged a complaint against accused namely Ramdhan Gope (38) S/O Lt- Shyamapada Gope of village- Patharkata. PS- Manbazar. Dist- Purulia to the effect that today (08.09.2020) at 15:05 hrs. I received a telephonic information from a reliable source that one Ramdhan Gope (38) S/O Lt- Shyamapada Gope of village- Patharkata. PS- Manbazar. Dist- Purulia was stocked Country Sprit illegally and selling the same to hike price for his personal gain then I noted this information in GD, vide Manbazar PS GDE No-271 Dtd 08.09.2020. I informed the matter to O/C Manbazar PS and as per order of O/C Manbazar PS myself along with C/1316 Ujjwal Mandal, HG 1443 Uttam Kr. Singh rushed to the spot for raid by Govt. vehicle. At about 15:35 hrs. myself along with force reached at Patharkata village and held raid in the house of Ramdhan Gope and found that said house owner selling ID liquor at his own house and Seeing the police party some persons fled away and said Ramdhan Gope tried to concealed himself but we are able to apprehend him and also detained him. I asked him to produce valid license or valid papers for selling ID liquor, but he failed to produce any valid license or documents for possessing / selling the same. So I arrested the above noted accused person informing the ground of arrest and seized the above mentioned articles after proper seizure list duly sign by accused person and available witnesses.

Hence, I therefore pray that a specific case may kindly be started against arrested accused person Ramdhan Gope (38) S/O Lt- Shyamapada Gope of village- Patharkata. PS- Manbazar. Dist- Purulia as per law and arrange for its investigation.
