Sir,

In producing herewith one seized vehicle (Tractor) Engine No. RJH2EAN6041 Chassis No. MBNABAEXPJ03551 loaded with sand. The fact of the case in brief is that on 25.09.2020, I A.S.I. Subhendu Mahato along with force were on evening mobile duty vide Manbazar PS GDE No- 957 dated - 25.09.2020, on Manbazar Purulia Road ( SH-5). During mobile duty on 25.09.2020 at about 17:15 hrs. received credible source information that the above noted vehicle (Tractor) is coming from Gopalnagar side towards Jabla village loaded with sand without valid paper. After receiving this information we proceeded towards Jabla village under Manbazar PS. When we reached Jabla village under Manbazar PS , found that the above noted vehicle (Tractor) was coming from Jabla village side. On seeing the police party the driver of the said vehicle (Tractor) stopped the Tractor in a distance from Jabla village and tried to unload the sand, loaded in a separate trolley with said vehicle (Tractor). We rushed to the vehicle and the driver then fled away after keeping the vehicle Jabla village at 18:05 hrs. We searched the said vehicle and found that the vehicle is loaded with sand. I searched for any valid documents in respect of sand loaded in the Tractor as well as the valid documents in respect of that Tractor but nothing found. Hence I seized the vehicle (Tractor) Engine No. RJH2EAN6041 Chassis No. MBNABAEXPJ03551 loaded with sand measuring approx 100 CFT in a trolley under proper seizure list in presence of available witnesses duly signed them. Thereafter arranging a driver from my source I brought the said vehicle to Manbazar PS. As such there is every reason to believe that the driver and owner of the vehicle (Tractor) Engine No. RJH2EAN6041 Chassis No. MBNABAEXPJ03551 with ill motive are transporting sand illegally without any valid document in support of carrying sand. So they are liable for offence punishable U/S - 379/411/414/120B IPC & 21 (1) (4) Mines and Minerals (R&D) Act. 1957.

Therefore, I pray before you that a case against the driver and owner of vehicle (Tractor) Engine No. RJH2EAN6041 Chassis No. MBNABAEXPJ03551 may kindly be started and arrange for its investigation.
