I, A. Ramesh site Incharge of Prince Thermal (I) Pvt. Ltd., RTPS, at about 08.30 P.M. on 31.08.2020 received a phone call that three of our (Prince Thermal (I) Pvt. Ltd.) labours by name Mr. Brihaspati Mahato , Mr. Kalinath Munda & Mr. Charan Munda had been obtained in the football ground of Naragoria Village by some of the local people. I rushed towards the coal gate on my bike with Mr. Anath . I stopped my bike near Coal Gate Naragoria. An unknown person came to me and asked me to go to the ground where three of my labours were held up. Some twenty to Twenty five boys were assembled at the ground and our three labours were sitting there in frightened conditions. The local boys present there asked me to induct at least ten (10) persons in my Company (i.e. Prince Thermal (I) Pvt. Ltd.) . There was a

short conversation in which I asked them that there is scope of only skilled labours in my Company as stone Picking work is very hazardous and so only trained labours can be engaged in the work . All on sudden they started abusing me and some of them stated hitting/punching me from all sides. Apart from acute pains I received injury adjacent to my left eye and head. Some how fled from the spot and reached hospital on hearing death threat from them . I reached DVC Hospital , RTPS at 9.55 P.M. Dr. Tanmoy Karmakar attended me and admised me for treatment . Doctor's prescription is hereby attached with this letter . Therefore I request you to take necessary action as soon as possible .
