In producing one seized Tractor without Registration number heaving engine No-RKH2KBA1628, Cassis No- MDNABAJAKKRH05857 loaded with sand approx 100 C.Ft do hereby lodge a complaint to the effect that today on 06.09.20 while I SI Kalyan Kumar Sakha along with C/1260 Santosh Soren, C/78 Utpal Sarkar and C/584 Madhab Ch. Majee all of Neturia PS vide Neturia PS GDE No. 255 Dt 06.09.2020 and CC No. 2419/20 Dt. 06.09.20 at about 15:15 hrs acting on source information I along with force reached at Parbelia 03 No. and found the above noted tractor was coming 03 No Damudor River ghat loaded with Sand. On seeing the police vehicle the driver of said vehicle fled away left the vehicle loaded with sand approx 100 Cft.

So, there is reason to believe that the driver, registered owner of the vehicle has collected the said sand either by theft or by any fraudulent means and after hatching a criminal conspiracy, they were trying to dispose of the same sand in a clandestine manner to Parbelia side knowing it to be stolen, as per their regular practice.

Accordingly I seized said Tractor without Registration number heaving engine No-RKH2KBA1628, Cassis No- MDNABAJAKKRH05857 loaded with sand approx 100 C. Ft in presence of my accompanied Police witnesses, since no public witness was found. So, the driver, registered owner of the vehicle has committed offence U/S-379/411/413/414/120B IPC & section 21 (4) MM (R&D) Act- 1997 amendment 2015 and I brought the said Tractor to Neturia P.S.

Under the above fact and circumstances a specific case may kindly be started against driver and owner of vehicle (Tractor) without Registration number heaving engine No-RKH2KBA1628, Cassis No- MDNABAJAKKRH05857 U/S- 379/411/413/414/120B IPC & section 21 (4) MM (R&D) Act- 1997 amendment 2015 and arrange its investigation.
