Sub: Prayer for starting a specific case.

Respected Sir,

In producing herewith one accused person namely Madan Bauri (39 Years) S/O- Kamal Bauri of Vill-Digha, PS-Neturia, District- Purulia with seizure of 24 pcs Sealed bottles of Dil Se Country spirit containing 300 ml each which were seized under proper seizure list.

I beg to submit that today (10.09.2020) while I, SI Kalyan Kumar Sakha along with force were performing anticrime evening mobile duty vide Neturia PS GDE No-465 Dt. 10.09.2020 and acting on source information after consulting you at about 18:45 hrs reached at Digha village and held raid in the house of Madan Bauri (39 Years) S/O- Kamal Bauri of Vill-Digha, PS-Neturia, District- Purulia and found that the above noted person was keeping / selling liquor which were kept in his house, on demand Madan Bauri failed to produce any valid documentary authority in respect of selling of liquor as well as nobody turned up to produce any valid documents. As such he committed offence u/s 46 A (c) B.E. Act and he was arrested U/S-67 BE Act and also 24 pcs. Sealed bottles of Dil Se Country spirit containing 300 ml each which were seized under proper seizure list duly signed by witnesses and labeled at the time of seizure. During arrest the ground of arrest was duly notified, issued arrest memo u/s- 50 Cr. P.C. and handed a copy of the same to arrestee.

The arrested accused namely Madan Bauri (39 Years) S/O- Kamal Bauri of Vill-Digha, PS-Neturia, District- Purulia has committed offence u/s 46 A(c) B.E. Act, 1909 for unauthorized possession and sale of liquor.

It may note here that during raid (1) C/584 Madhab Chandra Majee (2) C/1353 Atanu Ganguly and (3) C/1224 Gajan Murmu all of Neturia PS accompanied me.

Under the above facts and circumstances I therefore pray that a specific case may kindly be started against Madan Bauri (39 Years) S/O- Kamal Bauri of Vill-Digha, PS-Neturia, District- Purulia under proper section of law.
