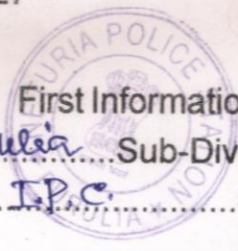

Sub: Complain to start a specific case.

Sir,

I, SI Kalyan Kumar Sakha of Neturia PS, Dist- Purulia do hereby lodge a written complaint against Tapash Mallick (19 Years) S/O- Achinta Mallick of Vill- Gram Parbelia, PS- Neturia, Dist-Purulia to the effect that today on 11.09.2020 while I along with C/1140 Dayamoy Mahato, C/382 Bipad Taran Chatterjee and NVF/636 Chatu Singh all of-Neturia PS as per direction engaged in special mobile duty in Neturia PS area vide Neturia PS GDE No- 497 dated 11.09.2020 for implementation of Government rules regarding Disaster Management Plan and while we reached at Chinakuri More near Rahul Hotel at about 12:05 hrs found that the above noted person was moving there without any valid reason and without wearing mask which violates the compliance of norms of Government order as well as wearing of mask during this pandemic situation. I took photograph and asked him about his presence there and also non- wearing of mask during this pandemic situation COVID-19 today called by state Government vide Memo No- 298-CS/2020 Dt. 31.08.2020 but he failed to give any satisfactory answer. So, he violated the compliance of norms of Government order as well as wearing of mask during this pandemic situation and committed negligent act likely to spread infection of diseases dangerous to life and violated Government rule U/S-188 IPC & 51 (1) (b) of National Disaster Management Act, 2005. I interrogated him and during interrogation he disclosed his identity noted above. After interrogation I arrested the above noted accused person after maintaining all formalities regarding arrest as he committed cognizable offence in presence of police U/S-188 IPC & 51 (1) (b) of National Disaster Management Act, 2005 and informed ground of arrest.

So, there is every reason to believe that the above noted person was moving at Chinakuri More near Rahul Hotel without any valid reason and without wearing mask under Neturia PS by violating the Government order during this pandemic situation and committed negligent act likely to spread infection of diseases dangerous to life.

Therefore, I pray a specific case may kindly be started against accused Tapash Mallick (19 Years) S/O- Achinta Mallick of Vill- Gram Parbelia, PS-Neturia, Dist-Purulia U/S- 188 IPC and 51 (1) (b) of National Disaster Management Act, 2005 as he disobeyed Govt. order and committed negligent Act likely to spread infection of diseases dangerous to life and violated Government rule and arrange for its investigation.
