P.S.-Neturia, Dist-Purulia beg to state that in our locality one ECL's vacate land situated near my house as we all inhabitants uses that land for our social programmes but on 14/9/2020 at about 4 P.M. ① Umesh Yadav s/o Atsharfi Yadav, ② Sachitanand Yadav s/o Umesh Yadav, ③ Janu Grope s/o Anil Grope, ④ Vivekanand Yadav s/o Umesh Yadav all of Amdhowra illegally tried to occupy the land by constructing peace and while protest they furiously assaulted me by fist and blows and with lathi, and when our neighbours Vicky Choudhary s/o Jai Ram Mallah, Sashika Shaw s/o Sanjay Shaw, Rahul Shaw s/o Bijay Shaw came to the spot, the aforesaid person used filthy language and assaulted them also, resulting I myself and my neighbours sustained injuries on our person.
