In producing herewith 06(Six) arrested accused persons namely persons 1)Manik Sha (42yrs) S/o Lt-Gafur Sha 2) Choto Sha (38yrs) S/o Lt- Gafur Sha both of Village Bamunbaid, 3)Kirity Bauri (24yrs) S/o Madhusudan Bauri of Village Jorberia, 4) Shyamapada Bauri (27yrs) S/o Bigai Bauri 5) Biplab Bauri (24yrs) S/o Abatar Bauri 6) Sanjoy Bauri (25yrs) S/o Kinu Bauri all of Village Jabarrah, all of PS Para, Dist-Purulia.

I beg to state that today (11.09.2020), I was directed to find out whether the lock down has been implanted properly at Dubra Bazar area or not. Accordingly, I had been to Dubra Bazar at about 13.45 hrs found that a gathering appeared at Dubra Bazar near Durga Mandir, none of them were wearing musk. On seeing Police party they have tried to escape from the grip of police party but some failed to escape due to efficient effort of police party. On being asked they disclosed their identity as noted above.

They violated the order duly promulgated by government through public servants and through media etc for prevention of attack from CORONA Virus/COVID-19. They are creating annoyance to the society & violated Govt. order. Though lockdown is going on throughout the West Bengal in view of Pandemic of COVID-19 outbreak vide Govt. of India consolidated order No- 40-3/2020-DM-1 (A) Date-24/03/2020 and further modified dated-25/03/2020, 27/03/2020, 02/04/2020, 03/04/2020, 10/04/2020 & 01/05/2020. And orders of Govt. of West Bengal vide Order No- 177-CS/2020 dt-18.05.2020 & 218-CS/2020 dt-30.05.2020, order No- 272-CS/2020 Dtd. 30.06.2020 and Memo no. 283-CS/2020 Dtd. 21.07.2020 and Order No- 285-CS/2020 Dtd- 30.07.2020 & Memo No- 287-CS/2020 Dtd- 03.08.2020 for complete restriction measure.

I arrested them for Disobedience to order duly promulgated by public servant after maintaining all rules of arrest, Issued memo of arrest & Inspection Memo. I informed them & their relatives regarding the ground of arrest i.e.as per section 3 of the Epidemic Diseases Act, 1897, provide penalties for disobeying any regulation or order made under the Act. These are according to Section 188 of the Indian Penal Code (Disobedience to order duly promulgated by public servant). At prima facie there were sufficient evidences to secure their detention. All the process was done in between 14.05 hrs to 14.35 hrs. There was every chance of breach of peace and requiring of offence if not arrested.

Therefore, I pray a specific case may kindly be lodge against 1)Manik Sha (42yrs) S/o Lt- Gafur Sha 2) Choto Sha (38yrs) S/o Lt- Gafur Sha both of Village Bamunbaid, 3)Kirity Bauri (24yrs) S/o Madhusudan Bauri of Village Jorberia, 4) Shyamapada Bauri (27yrs) S/o Bigai Bauri 5) Biplab Bauri (24yrs) S/o Abatar Bauri 6) Sanjoy Bauri (25yrs) S/o Kinu Bauri all of Village Jabarrah, all of PS Para, Dist-Purulia as they disobeyed Govt. order and committed negligent Act likely to spread infection of diseases dangerous to lie and violated Quarantine rule U/S 188/34 IPC and Section 51(1)(b) National Disaster Management Act- 2005 and arrange
