

The petitioner/complainant above named begs to state as follows:-

- 1. That on 12/04/2020 at about 1 P.M, when your petitioner and his son Diljan Ansari went to take bath at Burar Bandh at Mouza-Baghra your petitioner found that the accused No-1 to 4 were trying to catch the fish from the said Burar Bandh by putting big nets and made arrangement of different traps to caught the big fishes from the said Bandh, it has been further mentioned that the owners of the said Burar Bandh gave a possession on Patta bondobosto to your petitioner and your petitioner cultivate and rearing fishes in the said Bandh for many years and your petitioner has an exclusive possession over the Bandh by the way of lease but the aforesaid accused No- 1 to 4 forcibly and illegally tried to catch all the fishes from the aforesaid Bandh and when your petitioner and his son obstruct them to do such illegal act and protest to caught the fish from the Bandh illegally all the 4 accused suddenly assaulted your petitioner and his son with lathi and iron rod and accused no-6 to 9 brought some Stones, lathi and iron rod and gave accused no 1 to 4 to assaulted your petitioner and they tried to murdered your petitioner by assaulting him continuously with lathi and rod and all the accused no-6to 9 caught hold his hair and also caught his hands and legs tightly that your petitioner could not escaped from their grip and taking this advantage accused no- 1to 4 assaulted and bitten to your petitioner mercilessly as a result your petitioner sustained grievous bleeding injury over his back and chest and he started vomiting there with cough and blood and when his son tried to save your petitioner from the hands of the accused persons they also assaulted his son with stones and lathi, and his son shouted loudly to save your petitioner and himself and hearing the loud shout of your petitioner and his son some villagers and local people came to the spot at that time the accused persons were fled away and said that if he told anything about the incident before any person or Police he has to prepared for the dire consequences.
  - 2. That with the help of some villagers your petitioner and his son rescued from the place of incident and taken the injured Anowar Ansari and his son to Purulia Deben Mahato Sadar Hospital where the attending doctor admitted your petitioner and he had taking the treatment for 7 days and after 7 days he had been discharged from Purulia Sadar Hospital and for the treatment reason he was unable to inform the matter to the concerned police station on time.

- 3.That when the son of your petitioner namely Diljan Ansari shouting loudly and local people of the villages were started to gathered then the accused persons were fled away from the place threatening your petitioner not to informed the matter infore police or any other organization otherwise they were going to killed him.
- 4. That as there was no any chance of remedy your petitioner went to the Purulia(M) P.S on 23/04/2020 and one written F.I.R. has been lodged against the accused persons and concerned P.S. assured your petitioner that they will take action against the accused persons soon but did nothing and finally on 04/07/2020 the concerned P.S. advised your petitioner to take shelter of law.
- 5.That your petitioner filed one written complaint before the S.P Purulia on 06/07/2020 regarding the matter mentioned above and also mentioned to take action against the accused persons.
- 6.That your petitioner went to the concerned police station several times requesting to take action against the accused persons ,but no action has yet been taken by the concerned police station.
- 7. That, your petitioner is a very poor man and it is not possible for him to engage a private lawyer day to day. Moreover he is the victim and sustained a grievous injury the case should be referred to Purulia (M) Police Station for investigation.
- 9. That as the petitioner/complainant failed to get any relief from the P.S. as well as S.P. Purulia he is filling this Misc. Petition under section 156(3) Cr.P.C for reliefs as enumerated below and the accused persons has been threatening to your petitioner/complainant that if he informed the matter to any where he will face the consequent, your petitioner is a poor man and also a day to day worker and work hard to live his livelihood.
