Sub:- Complain Against Mr.Sourav Sinha and others

With reference to the subject mentioned above, this is to inform you that on 25/09/2020 about 70-100 people led by 1.Mr Sourav Sinha, Teacher, Kustaur High School 2. Rakshakar Pandey, Elected Member of Purulia-II Panchayat Samitibroke into the Block Office Compound without any prior permission. They used abusive language against me and other officials and staffs of my office. They shouted offensive slogans causing fear and chaos among the staffs and common people who had come for various official works in the block office. Most of them having no mask and not maintaining the social distance these ruffians flouted the Covid - 19 norms and thus endangered the officials and common people with the risk of being infected. I strongly recommend to take action against this Mr Sourav Sinha, Teacher, Kustaur High School 2. Rakshakar Pandey, Elected Member of Purulia-II Panchayat Samiti and some unknown persons for misguiding and leading this mob into the block office.


Much to my dismay one sub inspector of police namely Biswajit Kumar who was present at that time of hazard. But he had been mere spectator all the time and was least bothered to thwart the mob or take any action to provide security to the officials of Purulia-II Development Block and also to Block Development Officer, Purulia-II Development Block.
