Sir,

With due respect I SI Manjur Rahaman, beg to submit before you that on 07.09.2020 at about 18:55 Hrs while I was alongwith Holla mobile Duty officer & forces vide C.C. No- 2124/2020 dated- 07.09.2020 at Zilla School Morh and found following arrested persons were wandering there without Mask and detained them subsequently at the spot. On being asked the following persons could not able to give any satisfactory answer for that wandering on the road without mask. As such the following persons violated the order during this pandemic situation duly promulgated by Govt. of West Bengal vide Memo No- 298-CS/2020 dated- 31.08.2020 where are in order to contain and combat of Covid-19, State Govt. Vide Order No- 285-CS/2020 dated 30.07.2020 had notified containment zone-based lockdown measures upto 31.08.2020. Now, in consideration of the current Covid-19 situation, Lock down in the containment zones stands extended up to 30.09.2020. Moreover all the detained persons were making and circulating false alarm or warning as to disaster or its severity or magnitude, leading to panic among people and as well as the society. Accordingly the following persons were arrested from 19:25 Hrs. to 20:25 Hrs after maintaining all formalities regarding arrest and brought them to P.S.
