I, Smt.Bhabani Roy, w/o Lt Ajit Roy, of qtr No 112-D, B-Block, Senraleigh, PS Asansol North, do hereby seek your kind attention over untimely, sadden suicidal death of my son, Santu Roy, My son, Santu Roy married with Mamata Roy, D/0 Biren Singha of Mondal Para, Neamatpur, PS: Kulti, on 8/8/2011 as per Hindu rites and customs. The marriage was arranged one. After marriage my son started to spend conjugal life with Mamata Roy at my house. But mamata Roy is a lady of quarrel some, suspicious, and loose character one. She used not to concentrate in hjer conjugal life with my son, She even did not giv the right of a husband to my son. She always used to torture physically, mentally my son. She did not tender her hand to family work and always engaged on her phone with someone, later on, it came to learn that she has an illicit affair with some one. For that my son and me have several times requested her to change her attitude but she used to get irritated upon us . She used to torture continuously my son and for that he has been totally upset in his life. I hargyeral times requested Mamata father, namely, Biren singha, mother, namely, Ruma Singha, Brother, namely, Bijoy singha to advice Mamata to change hersif but they instead of advising Mamata abused and assaulted us. They would instigate Mamata to demand money from Santu Roy and at their instigation, Mamata used to demand money and while my son refused to pay then she would threaten him with implication of false criminal cases.

On 11.09,2020 she has forced an pushed me out of my house and when my son protested she also abused and torcher my son over phone and when my son requested him to change her behiver and otherwise he will be dying as because he has not been capable of going through this type of maintal tourcher any more.

Then on 10.09.2020 asked him that he may do anything she does not care for that an also provoked him to commite suicied if she cannot any more. Hearing that my son become very fed up and he told me that his life was m in ingless and then I tried to console him but he remain upset and on 12.09.2020 he commited suicied by hanging. He left a suicide not in respect of his death.

So I pray FIR may kindly lodge against my daughter-in-law Mamata Roy, W/O Late Santu Roy daughter of Biren Singha, nowshe is retained at Mandalpara, P.O-Neamatpur, P.S-Kulti, Dist-Paschim Bardhaman. Delay in lodging FIR due to fuineral ceremony of my son, please consider me.
