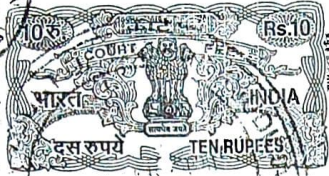

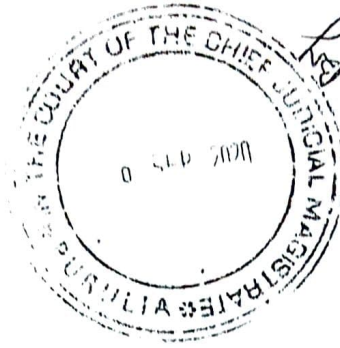

The Complainant named above begs to state as follows:-

- 1) That the Complainant is the legally married of the Accused no-1 and the Accused no- 2 happens to be the father-in-law and Accused no-3 happens to be the brother-in-law of the Complainant.
- 2) That their marriage was solemnized on 18/04/2016 in accordance to the Hindu Laws of Marriage and the rites and customs prevailing in their society at the parental house of the Complainant.
- 3) That at the time of marriage as per the demand of the Accused Persons, the mother of the Complainant, i.e. the Witness no-2, had to pay cash of Rs. 1,50,000/- (Rupees One Lakh & Fifty Thousands), Gold ornaments of 47.2 gm, Furniture, beddings and other utensils to them as dowry. After the marriage, the Complainant was taken to her in-laws house at Chandralok Bhawan, Devendra Lane, Road no-8 E, Ashok Nagar, Kankarbagh, Patna, Pin-800020, Bihar and also started residing with her husband along with her father-in-law Sri Prabhat Bhushan, as well as her brother-in-law Sri Utpal Vishal in a joint family and in a common mess.
- 4) That soon after their marriage, all the Accused Persons started to humiliate the Complainant and also started to use abusive languages. They started to torture her both physically and mentally on various ways as they are not satisfied with the dowry paid to them. She often used to be beaten by her husband. Though her husband earns a huge salary but due to continuous pressurization by her husband and his father, the Complainant was compelled to join the Strategic Alliance Management Service Pvt. Ltd (SAMS) under UNICEF at Patna, Bihar as HR

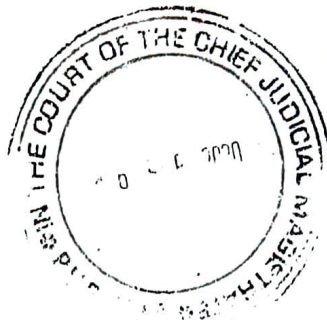

Officer but she was compelled to hand over her entire salary to her husband as per his direction and his husband did not pay any amount towards the maintenance of the family. The entire family was maintained by using the entire amount of the salary of the Complainant.

- 5) That the Complainant was started realizing that the Accused Persons just with the intention of grabbing money of her salary, compelled her to join the job. Whenever she protested, she used to face inhuman torture by her husband, her father-in-law and brother-in-law. They used to provoke the Accused no-1. The Complainant used to maintain her entire in-laws family as a Hindu devotee wife and used to do all domestic works of the house just like a maid servant and after doing all such works of the house, she used to go to her office but she never permitted to take and/or to use a single farthing from her own salary for her own personal purpose.
- 6) That subsequently the Complainant gave birth to a female child out of the paternity of the Accused no-1 in the year 2017. The Complainant had compelled to go to her office along with her new born suckling baby as there was no one in the family who used to take proper care of her child. Her husband never took any care to their new born baby. He neither performed his duties towards her wife nor even during her pregnancy as well as nor till today.
- 7) That subsequently the Accused Persons started creating persistent torture upon the Complainant for demanding a further amount of 12 Lakhs as additional dowry from her and from her mother which they failed to pay. To take revenge, the Accused No-1 fraudulently with some undue interest, without the consent of the Complainant, keep all her gold ornaments before Muthoot Finance, Patna as mortgage for taking a loan for his personal purpose. After getting information about the same, the Complainant raised objection against such illegal acts of her husband but she was brutally assaulted by her husband. The entire streedhans(Gold Ornaments) are still lying with the said Finance Company. Thereafter on 20/02/2019 all the Accused Persons assaulted the Complainant mercilessly and she was driven out from their house and since then she was compelled to reside at her parental house at Purulia along with their minor child as a result of which the Complainant has compelled to leave her job.
- 8) Thereafter the Complainant took shelter of law and lodged a Complaint before the Protection Officer, Purulia for which a case under Protection of Women from Domestic Violence Act and also a proceeding for Maintenance were started

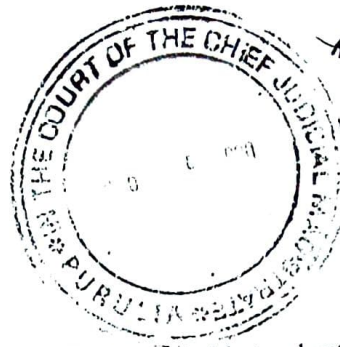

against the Accused no-1 and after knowing the institution of the cases filed by the Complainant, the Accused no-1 suddenly on 06/02/2020 came to her parental house and in presence of her family members, with folded hands, the Accused no-1 promised that he will never do any kind of torture upon the Complainant. Initially the Complainant did not believe upon his contention but subsequently on 15/03/2020 the Accused no-1 and 2 came to the parental house of the Complainant and in presence of her mother and other family relative said that they are sorry for everything whatever they did and they want to get a 2nd chance and want to take the Complainant back.

- 9) That on constant and persistent request of the Accused Person no-1 and 2 as the Accused no-1 undertook that he would maintain the Complainant and their daughter properly with due love, care, respect and affection, the Complainant and her family members trusted upon their misrepresentation and in order to lead a happy conjugal life, the Complainant took initiative to withdraw the said cases under Domestic Violence Act vide Misc Case no. 261 of 2019 pending in J.M. 2nd Court, Purulia and the case of maintenance vide Misc case No. 244 of 2019, pending in the court of Ld. C.J.M, Purulia, and accordingly the case under PWDV Act was withdrawn in terms of compromise but the case of maintenance is still pending for further hearing.
- 10) That after the aforesaid withdrawal, the Complainant went back with her husband and father-in-law to Patna along with their daughter on 16/03/2020 believing their version with a new hope. But once again she faced inhuman torture there, by the hands of my husband and his other relatives. They often used to use abusing languages to her. They even did not allow her to make any phone call to any of her family members as well as friends against which she protested and for the very reason on 20/03/2020 the Complainant was beaten by her husband and his brother i.e. the Accused no-3. They snatched her mobile phone and they also threatened her to kill, if she will make any conversation with any of her family members or with anybody else any further. They also told the Complainant that it was nothing but a plan to take her back to Patna and to withdraw the cases which the Complainant filed against them. She became astonished when she came to know about the intention of Accused Persons to deceive her.
- 11) That the Complainant started feeling helpless as she found herself and their daughter caught in a trap which made by the Accused Persons with undue

interest. The Accused no-1 only wants to satisfy his physical lust and nothing else. He behaved with the Complainant like a wild animal. Almost all night he tortured her sexually. She started getting physically ill. The Accused no-1 also stopped to bring the necessary items for herself and for their daughter's livelihood. The torture was accelerated day by day.

- 12) That the Accused Persons on 10/04/2020 at midnight, with intention to kill the Complainant, forcibly administered 11 tablets of pain killer to her due to which she became physically ill and started vomiting. They did not take her to any doctor for treatment. She became seriously ill. The mother and other family members of the Complainant tried to contact with the Accused Persons over phone but they started avoiding them. The father-in-law of the Complainant also threatened her not to say anything to anyone about any torture upon her. They also threatened her of dire consequences.
- 13) That the Complainant along with her daughter started to pass their days in such a scary situation and to pass their nights sleeplessly. Lastly on 19/05/2020 the Complainant, along with her daughter, anyhow managed to come back to the parental home of the Complainant at Purulia during the time of lockdown declared under COVID-19 situation, and since then they are residing there.
- 14) Thereafter the Complainant on 20.08.2020 had been to P.S and informed the matter to the Police of Purulia(T) P.S. but the reason best known to them, they refused to accept the same accordingly, the complainant send the complaint through registered post on 29.08.2020. But as no step was taken by the Police, the Complainant on 04.09.2020 informed the matter to the Superintendent of Police, Purulia but even then as no step has been taken against the Accused Persons by the police, the Complainant is being compelled to lodged this Petition u/s 156(3) Cr.P.C. before Your Honour's Court.
- 15) That the Accused Persons have thus committed offences punishable ~~u/s~~ ~~323/498A/417/307/506/34 IPC and 3 and 4 D.P. Act.~~ under law.
- 16) That the Complainant being a helpless lady is unable to arrange for producing the Witnesses in Court at his own cost. Moreover in the instant case various documents, medical papers are to be seized and the recovery of the Gold Ornaments are yet to be done which could not be possible without police help.
