In producing herewith the arrested accused persons namely (i) Helal Ansary (42 yrs) s/o Lt Jalaluddin Ansary of Palanja PS Purulia (M) Dist Purulia and ii) SK Samim @ Shamim (34 yrs) s/o Lt. SK Alijan of Chunavati Islamnagar, JK College road PS- Purulia (T), Dist- Purulia and a seized white colour Innova car bearing Reg. No JH05BG/9552, Engine No 2KDS569576 and Chassis No MBJ11JV4007544168, I beg to lodge this complaint against both the above named arrested accused persons to the fact that, today (28.09.20) at 15:35 hrs you as O/C of the PS had received a credible source information vide Purulia (T) PS GDE No 1500 dt. 28.09.20 that the above named persons were coming towards Purulia Township from Joypur side with a white colour Innova car in order to sell the theft white colour Innova car at Purulia Township in the open broad day light and as per your order I with ASI Dipak Bandyopadhyay, JC/386 Sourav Kr. Sau, JC/366 Debsankar Barik, JC/43 Uttam Man, JC/1263 Tarun Sahoo, CVF/2435 Ramesh Mandal, CVF/2348, CVF/2440 Ratan Bauri left for Judge Bungalow more on Ranchi Road (NH 32) along with the source to work out the information vide Purulia (T) PS GDE No 1501 dt. 28.09.20 & C.C. No 2301/20. Reached at Judge Bungalow more on Purulia – Ranchi Road around 16:15 hrs and started Naka checking. At 16:40 one white colour Innova vehicle could be seen coming towards Purulia side and seeing the police checking, the car stopped beside the road and three men got down and tried to flee. The source identified one Pappu Khan of Purulia Kalanderdanga out of them. We chased them and after a hot chase we could able to apprehend two persons namely (i) Helal Ansary (42 yrs) s/o Lt Jalaluddin Ansary of Palanja PS Purulia (M) Dist Purulia and ii) SK Samim @ Shamim (34 yrs) s/o Lt. SK Alijan of Chunavati Islamnagar, JK College Road PS- Purulia (T), Dist- Purulia. On being asked they failed to produce papers in respect of the vehicle. After repeated interrogation, they admitted that the vehicle was a stolen one procured by them by committing theft from Jugsalai, Jamshedpur. They also confessed before all of us that, they are professional vehicle lifter and have stolen away many vehicles form different places under the leadership of Pappu Khan S/O Manjur Khan of Kalanderdanga PS Purulia (T) Dist Purulia.

I, as such seized the white colour Innova car bearing Reg. No JH05BG/9552 having Engine No 2KDS569576 and Chassis No MBJ11JV4007544168 under proper seizure list prepared by me on the spot and arrested both the intercepted accused persons as above as disclose by them subsequently after observing all formalities regarding arrest. I arranged to send information for intimation to the house inmate of both the arrested accused persons at village Palanja and Purulia Chunavati Islamnagar.

I prepared label in r/o the said seized Innova vehicle after observing all formalities regarding seizure. I supplied copy of seizure list to the accused persons under their signature as mark of acknowledgement.

Since the circumstances laid to hold my view and as per believable confessional statement of both the arrested accused persons disclosed an offence punishable u/s 379/411/413/414/120B IPC committed by them, I pray that a specific case accordingly may kindly be started against both the arrested accused persons (i) Helal Ansary (42 yrs) s/o Lt Jalaluddin Ansary of Palanja PS Purulia (M) Dist Purulia ii) SK Samim @ Shamim (34 yrs) s/o Lt. SK Alijan of Chunavati Islamnagar, JK College road PS- Purulia (T), Dist- Purulia and (iii) Pappu Khan S/O Manjur Khan of Kalanderdanga PS Purulia (T) Dist Purulia who has fled away and to arrange its investigation.
