



Complainant most respectfully showeth:-


1. That being a major lady complainant married to her beloved Sibnath Paramanik, a Teacher on 06-03-2020.
2. That accd. persons happen to be the mother, elder sister and younger brother of the complainant and they were/are not at all satisfied with such decision of the complainant. As a matter of fact accd. persons had never allowed or entertained any decision of the complainant even after her attaining age of majority. However petitioners/complainant's such decision appeared to be hardend to the accd. person so they could not digest the same.
3. That maiden life of the complainant was so pitiable and sorrowful due to the ill behaviour and illtreatment on the part of accd. persons.

Needless to say just after death of father Bijoy Gorai ~~she~~ torture upon complainant and so drastic and unbearable and in the said juncture her husband render his support to bring her out from the savage clutches of accd. persons.

4. That marriage of the complainant was love marriage one and hearing the news of marriage accd. persons so cleverly called her at paternal house on 07-03-2020 at 5-30 P.M. on a pretext in which complainant had been to her paternal house from her husband's house but it was her irony of fate that she was paid with some unimaginable treatment from her mother, sister and brother. Accd. seeing her coming suddenly caught hold her neck and started assaulted ~~unmercilessly~~ in which complainant got shocked and panicked but accd. did not allow ~~xxxx~~ her to say something rather they dragged her inside the room snatched the earrings chain from the complainant. Accd. persons also sub-due to bring out her all documents viz marksheets, ATM Card PAN Card Bank account from almirah of the complainant and the also ^{for} subservice purpose accd. persons forcefully at daggers point compelled the complainant to put signature in blanksheet.

5. That accd. persons also threatened the complainant with dire consequence. Even accd. persons also gave out threat to bring an end of the life of newly married husband by deploying some anti-social element. Ultimately complainant was driven out by the accd persons from her father's house.

6. That the complainant apprehends that accd. must have used such documents of complainant for some illegal purpose. More so amount near about five lakhs lying with Bank account of complainant and there is every chance of misappropriation of said amounts at the best of accd. persons since they are in illegal possession of A.T.M. Card Bank account of the complainant.

7. That complainant informed the matter in writing with Raghunathpur P.S. on 07-03-2020 against the accd. persons but police authority did not take any step inspite of passing sufficient time. Be it mentioned ^{amid} COVID-19 and sudden lockdown imposed in the country complainant could not approach before any forum for her remedy. On 22-06-2020 complainant lodged her grievance to the superintendent of police, Purulia against non taking action of Raghunathpur Police station but she got nothing hence complainant seeks her redressal before the Ld. court.

Under such circumstances it is most respectfully prayed that necessary direction may kindly be passed upon I/C Raghunathpur to cause investigation into the matter after treating the instant as F.I.R. U/S 156(3) Cr.P.C.
