


1. That the complainant and accd. persons are well known to each other being co-resident of same village:-Khajura within

2. That acced. persons are very much deterent and determined to cause mischief of the property and persons of the complainant and in such view accd. persons without any reason prevented the complainant from taking bath in the morning in "BAROBANDH" of Khajura Village on the day of incident.

3. That elder brother of the complainant having heard such illegal & overt act of the accd. persons from his brother went to the accd. persons alongwith complainant at melevent point of time and found them at Hari Temple premises.

4. That as soon complainant and his elder brother enquired from the accd. persons for their doing such illegal act all the accd started abusing the complainant and his elder brother with filthy language and started assaulting both of them with fist and blows, kicks as a result elder brother of the complainant felt on ground and accd. person Dolon Bhakat heavily assaulted the complainant on his head with a sharp stone, resulting a bleeding injury of the person of the complainant other accd. person also caught hold the hands and neck of the complainant.

5. That accd. also gave out threat that they will finish the life of the elder brother of the complainant on any opportunate moment

6. That complainant got treated his injury at Raghunathpur Hospital.
