Respected Sir,

In producing here with one arrested accused person namely Sanjay Kaibarta (31) S/o Ganesh Kaibarta of village Unanshila, PS-Raghunathpur, Dist-Purulia with seized articles (1) One TATA ACE Van having registration no WB81/1240 loaded with (2) Rice 10 (Ten) Bags fully loaded in packet condition of 50 Kg each mark as "Food Grains Commodity Paddy Rice"-KMS 2019-20 Apex mark Fed manufactured in Indian and (3) Wheat 14 (Fourteen) Bags fully loaded in packet condition of 50 Kg each, marked as "Madhya Pradesh State Civil Supplies Corporation, Year 2020-21 manufactured PP mill Pragati Udyog Pvt. Ltd. Kolkata (manufactured in India).

I beg to report that today morning I, ASI Mujibar Rahaman, C/638 Lal Chand Bag, C/217 Swarup Singh all of Raghunathpur PS were engaged in day mobile duty in Raghunathpur PS area vide Raghunathpur PS CC No. 1867/20 dated 08/09/2020 and introduced Naka Checking near to Chinpina Rly Gate on Purulia - Bankura Pitch Road. At about 13:45 hrs I detained one TATA ACE Van having registration no WB81/1240 and on searched I found the said vehicle is loaded with articles (1) Rice 10 (Ten) Bags fully loaded in packet condition of 50 Kg each mark as "Food Grains Commodity Paddy Rice"-KMS 2019-20 Apex mark Fed manufactured in Indian and (2) Wheat 14 (Fourteen) Bags fully loaded in packet condition of 50 Kg each, marked as "Madhya Pradesh State Civil Supplies Corporation, Year 2020-21 manufactured PP mill Pragati Udyog Pvt. Ltd. Kolkata (manufactured in India). On demand the driver of the said vehicle failed to produce any document / challan in respect of the said articles as well as in respect of the vehicle. On interrogation driver of the said vehicle made incoherent statement and stating that he procured the above noted articles from Unanshila M.R. Shop duly loaded in the said vehicle as per direction of the owner of the Unanshila M.R. Shop (Fair Price Shop) and was going to deliver the same in Raghunathpur Town area in connivance with him (the driver / owner of the said vehicle) with a view to clandestine business and wrongful gain knowing it fully well that the said articles is rationing commodities. But he failed to give the name of the place of disposal of the said articles. As such finding no any other alternative way I seized the above noted articles including the vehicle in between 14:25 hrs and 15:15 hrs preparing proper seizure list duly signed by the witnesses and after that I arrested him at 15:25 hrs after observing all the formalities as per law and narrating him the ground of arrest.

Hence driver of the vehicle namely Sanjay Kaibartya (31) S/o Ganesh Kaibartya of village Unanshila, PS-Raghunathpur, Dist-Purulia and owner of the M.R. Shop of Unanshila village committed an offence punishable under Essential Commodities Act, 1955 for violation the provisions as mentioned in Government Notification No. 2347-FS/SEctt/Food/4P-09/2012 dated 08/08/2013 under the West Bengal Public Distribution System (Maintenance & Control) Order, 2013.

I therefore pray before you, kindly lodge an FIR against the accused driver namely Sanjay Kaibarta (31) S/o Ganesh Kaibarta of village Unanshila, PS-Raghunathpur, Dist-Purulia and owner of the M.R. Shop of Unanshila village as per law and arrange for its investigation.
