Sub:- Prayer to lodge FIR against 12 (Twelve) arrested accused persons.

Sir,

In producing herewith arrested accused persons (1) Dinesh Das (29), S/O Anil Das, (2) Raju Goswami (22), S/O Ukil Goswami, both of Ushir, (3) Sk. Nizam (37), S/O Sk. Tayub of Velatard, all of PS - Santaldih, Dist. - Purulia, (4) Amjad Ansary (32), S/O Jahangir Ansary of Hodla, (5) Jicko Ansary (34), S/O Asgar Ansary of Hodla, (6) Akash Bauri (19), S/O Lakaram Bauri of Narira, **Sl. No. 4 to 6 are PS - Raghunathpur, Dist. - Purulia**, (7) Ghangur Kumbhakar (23), S/O Karali Kumbhakar of Darda, (8) Fatik Mahato (42), S/O Bankim Mahato of Karanbandh, both of PS - Para, Dist. - Purulia, (9) Nepal Roy (27), S/O Kishan Roy of Polkudri, (10) Phani Bhusan Bauri (29), S/O Kiran Ch. I, SI Dipankar Biswas of Santaldih Investigation Centre, beg to submit that today (11/09/2020) at about 15:05 hrs, while myself along with force were performing special mobile duty and found the above noted persons were moving aimlessly at BCW Bus-stand area under Santaldih P.S. I along with force detained them at BCW Bus-stand and being asked they could not able to give any satisfactory answer for their presence at that place. Though lockdown is going on throughout the district of Purulia in view of Pandemic of COVID - 19 outbreak. As such the above persons violated the order during this pandemic situation duly promulgated by Govt. of West Bengal vide Memo No. 285 - CS/2020, dated 30/07/2020 which extend up to 30/09/2020 and Memo No. 298/CS/2020 dated 31/08/2020 of Chief Secretary, Govt. of West Bengal. Moreover, all the detained persons were refused to comply the direction given by the State Govt. to combat the rapidity of COVID - 19 pandemic. All the accused persons also tried negligently to spread infection of disease dangerous to life. Accordingly, they were arrested after maintaining all legal formalities regarding arrest and prepared arrest memos and brought them to PS.

Under above circumstances, I, therefore, pray, that a case U/S 188/269/270 IPC & Read with section 51 of Pandemic Disaster Management Act, 2005 may kindly be initiated against (1) Dinesh Das (29), S/O Anil Das, (2) Raju Goswami (22), S/O Ukil Goswami, both of Ushir, (3) Sk. Nizam (37), S/O Sk. Tayub of Velatard, all of PS - Santaldih, Dist. - Purulia, (4) Amjad Ansary (32), S/O Jahangir Ansary of Hodla, (5) Jicko Ansary (34), S/O Asgar Ansary of Hodla, (6) Akash Bauri (19), S/O Lakaram Bauri of Narira, **Sl.
