Sir.

In producing herewith the arrested accused person namely Najrul Ansari (32) S/O Inul Ansari of Kankibazar, PS – Santaldih, Dist. – Purulia, along with seized articles viz (i) One white coloured nylon bag, marked as Exhibit - "A" (ii) One white colour plastic Jaricane along with red coloured cap containing 3623 grams (including Jaricane) of light red coloured codeine like mixture, marked as Exhibit - 'B' (rest mother sample after taken out Exhibit Mark "C' & "D"), (iii) 100 grams (including bottle) of codeine like mixture as test sample marked as Exhibit - 'C" and (iv) 100 grams (including bottle) of codeine like mixture as security sample marked as Exhibit - "D". Exhibit mark B & C were collected from mother sample which was 3823 grams (including Jaricane) of light red coloured codeine like mixture. All Exhibits are in properly sealed and labelled condition under proper seizure list.

I, S.I. Dipankar Biswas of Santaldih Investigation Centre under Santaldih PS do hereby lodge a written complaint against the aforesaid accused person to the effect that on 31/08/2020 at 19.35 hrs myself received a telephonic information that the above noted accused person will come at Cinemtola more (near Hanuman Temple) under PS Santaldih for selling codeine mixture at about 20.45 hrs. I, informed the same to I.C. Santaldih PS through his cell phone. On getting verbal permission from him, myself along with ASI Lokes Das, C/105 Partha Tewary and C/663 Ashim Kobi all of Santaldih Investigation Centre, left Santaldih Investigation Centre at 19.50 hrs, vide Santaldih I.C. (BCW) GDE No. 408, dated 31/08/2020. I took prepare, carbon, Seal Gala, Candle, Match box, Investigation Centre Govt. round seal, some small plastic containers, Electronic weighing balance, narcotic kit box and investigation box containing print blank arrest memo, seizure list inventory list etc with us from Santaldih Investigation Centre. On reaching there i.e. Cinematola more (near Hanuman temple) under Santaldih PS at about 20.05 hrs we tried to call 2 (two) local persons but I did not find any persons there. Then on 31/08/2020 at about 20.15 hrs, we ambushed there. At about 20:35 hrs, we found the above noted accused person was coming from Santaldih station road with one nylon bag on his right hand. On identification of source we apprehended him at Cinematola More in front of Hanuman Temple under Santaldih PS. We disclosed our identity as police personnel before him and on being asked he disclosed his identity as noted above. I told him that I have definite information that he is carrying codeine like mixture jaricane on his bag. I accordingly informed the matter to I.C. Santaldih PS through his mobile phone at 20:45 hrs, about the fact and requested him to arrange for a magistrate if possible for conducting search at the spot. At 21:10 hrs, Sri Prasenjit Das, I.C. Santaldih Police Station, being a Gazetted officer reached the spot as no Magistrate or other Gazetted officer available and disclosed his identity as Gazetted officer to the above noted detainee and satisfied that he was carrying codeine like mixture. In presence of him I asked detainee Najrul Ansari whether he wants to be searched by a Magistrate or by a Gazetted officer. In this respect I issued him a written notice duly acknowledged by the detainee. In reply in writing he stated that he has no objection if he was searched by any police personnel on that notice. We also offered him to search our persons and he searched all police personnel but nothing objectionable was found. Hence "NIL" search list was prepared. I prepared inventory of articles possessed by the police party at 21.25 hrs. Then as per order of Sri Prasenjit Das, I.C. Santalih Police Station and in front of the above noted police witnesses I recovered said nylon carrying bag from the right hand of above Najrul Ansari containing white coloured jaricane loaded with codeine like mixture. I get it weight by weighing machine and the weight is of codeine like mixture 3823 grams (including jaricane). On being asked he told that he came there to sell codeine like mixture. On demand he failed to produce any valid license or papers in support of his possession of illegal codeine like mixture. As per order of IC, Santaldih P.S., I seized the articles i.e. (i) One white coloured nylon bag, marked as Exhibit - "A" (ii) One white colour plastic Jaricane along with red coloured cap containing 3623 grams

(including Jaricane) of light red coloured codeine like mixture, marked as Exhibit - B (rest mother sample after taken out Exhibit Mark "C' & "D"), (iii) 100 grams (including bottle) of codeine like mixture as test sample marked as Exhibit - "C" and (iv) 100 grams (including bottle) of codeine like mixture as security sample marked as Exhibit - "D". Exhibit mark B & C were collected from mother sample which was 3823 grams (including Jaricane) of light red coloured codeine like mixture. I sealed and labelled the said 4 (four) nos. of Exhibits in presence of IC, Santaldih PS, duly signed by them i.e. Police witnesses, accused person and IC Santaldih PS too.

The seizure was made on 31/08/2020 in between 21.45 hrs and 22.50 hrs. Them I arrested the accused Najrul Ansari (32) S/O Inul Ansari of Kankibazar, PS – Santaldih, Dist. – Purulia, on 31/08/2020 at 22.55 hrs, after maintaining all formalities of arrest. Inventory of NDPS articles were also done.

I, therefore, pray, that a case U/S 21(C) NDPS Act may kindly be started against the accused person Najrul Ansari (32) S/O Inul Ansari of Kankibazar, PS - Santaldih, Dist. - Purulia and arrangement may kindly be made for its investigation.
