I, SI Biswajit Murmu of Santaldih PS, beg to submit that today (31/08/2020) at about 22:25 hrs, while myself along with force were performing special mobile duty and found the above noted persons were moving aimlessly at Birsachak Morh under Santaldih P.S. I along with force detained them at Birsachak Morh and being asked they could not able to give any satisfactory answer for their presence at that place. Though lockdown is going on throughout the district of Purulia in view of Pandemic of COVID - 19 outbreak. As such the above persons violated the order during this pandemic situation duly promulgated by Govt. of West Bengal vide Memo No. 289 - CS/2020, dated 12/08/2020. Moreover, all the detained persons were refused to comply the direction given by the State Govt. to combat the rapidity of COVID - 19 pandemic. All the accused persons also tried negligently to spread infection of disease dangerous to life. Accordingly, they were arrested after maintaining all legal formalities regarding arrest and prepared arrest memos and brought them to PS.


