Sir,

In producing herewith arrested accused persons (1) Pankaj Sahani (19), S/O Sanjoy Sahani, (2) Chiranjit Mukherjee (21), S/O Patit Paban Mukherjee, both of Belkura, (3) Susanta Kr. Khan (20), S/O Amarnath Khan of Kankibazar, (4) Surajbabu Ansary (20), S/O Surufuddin Ansary of Kankibazar (Hattola), (5) Anand Gupta (42), S/O Prem Shankar Gupta of Kankibasti (Hattola), (6) Badal Ch. Gorain (52), S/O Lt. Surendra Gorain of Kankibasti, (7) Manbhul Gorain (70), S/O Lt. Khapu Gorain of Anantapur, All of PS - Santaldih, Dist. - Purulia, (8) Bhagaban Bouri (60), S/O Lt. I, SI Sourav Kanti Das of Santaldih PS, beg to submit that today (11/09/2020) at about 14:15 hrs, while myself along with force were performing special mobile duty and found the above noted persons were moving aimlessly near STPS Township Gate no. 1 under Santaldih P.S. I along with force detained them in front of STPS Township Gate no. 1 and being asked they could not able to give any satisfactory answer for their presence at that place. Though lockdown is going on throughout the district of Purulia in view of Pandemic of COVID - 19 outbreak. As such the above persons violated the order during this pandemic situation duly promulgated by Govt. of West Bengal vide Memo No. 285 - CS/2020, dated 30/07/2020 which extend up to 30/09/2020 and Memo No. 298/CS/2020 dated 31/08/2020 of Chief Secretary, Govt. of West Bengal. Moreover, all the detained persons were refused to comply the direction given by the State Govt. to combat the rapidity of COVID - 19 pandemic. All the accused persons also tried negligently to spread infection of disease dangerous to life. Accordingly, they were arrested after maintaining all legal formalities regarding arrest and prepared arrest memos and brought them to PS.

Under above circumstances, I, therefore, pray, that a case U/S 188/269/270 IPC & Read with section 51 of Pandemic Disaster Management Act, 2005 may kindly be initiated against (1) Pankaj Sahani (19), S/O Sanjoy Sahani, (2) Chiranjit Mukherjee (21), S/O Patit Paban Mukherjee, both of Belkura, (3) Susanta Kr.
