(BCW) under Santaldih PS do hereby lodge complaint that today (15.09.2020) at 14.55 hrs, when myself along with force were engaged in COVID-19 special mobile duty at Santaldih I.C. area and found the above noted persons were moving at BCW Bus-stand more under Santaldih PS, without wearing Mask or any face guard, as such I detained them on that spot.
