(7) Sailen Bouri (34 yrs) S/O-Gour Bouri of Bandha Moutor (Near Bus stop), PS-Raghunathpur, Dist-Purulia do hereby lodge a written complaint against them to the effect that today on 11.09.2020 while I along with C/1052 Shyamlal Murmu & NVF/913 Rajib Mahato of Santuri PS as per direction engaged in mobile duty within Santuri PS area (Reference Santuri P.S G.D.E No. 417 dtd. 11.09.2020 vide C.C. No. 3332/20 dtd. 11.09.2020) for implementation of Government rules regarding lockdown of Disaster Management Plan. While we were proceeding towards Balitora side through Madhukunda Bazar under Santuri P.S jurisdiction and reached near Madhukunda Railway Station entry gate at 15:05 hrs. found that the above noted 07 (seven) persons were go'ssiping without maintaining Lock down norms as well as without wearing a mask and maintaining social distancing which violates the compliance of norms of wearing of mask and maintaining social distancing during this pandemic situation in c/w COVID-19. So, there is every reason to believe that the above noted persons were moving during lock down time without wearing a mask and maintaining social distancing which violates the compliance of norms of wearing of mask during this pandemic situation and committed negligent act likely to spread infection of diseases dangerous to life and violated Government rule. So, I have arrested them maintaining all legal formalities as well as notifying the ground of arrest and informed their family members through local people.

Mahamad Alam (34 yrs), S/O-Md. Muktar Alam of Madhukunda Upardih, PS-Santuri, Dist-Purulia, (4) Baban Mitra (32 yrs) Swapan Mitra of Madhukunda Station Bazar, PS-Santuri, Dist-Purulia. (5) Rabindra Besra (45 yrs) S/O- Late Jagat Besra of Dumdumi near ACC Cement Factory, PS-Santuri, Dist-Purulia, (6) Mithun Baskey (22 yrs) S/O-Sanatan Baskey of Nimtikuri, PS-Santuri, Dist-Purulia, (7) Sailen Bouri (34 yrs) S/O-Gour Bouri of Bandha Moutor (Near Bus stop), PS-Raghunathpur, Dist-Purulia under proper section of law as they disobeyed Govt. order and committed negligent Act likely to spread infection of diseases dangerous to life and violated Government rule and arrange for its investigation.
