Gopinathpur, P.S Beliatore, Bankura do hereby produced (1) Pintu Bauri (33yrs) S/O- Dulal Bauri of Mohanpur, PSenturi, Dist-Purulia, (2) Biswajit Bauri @ Bishu (36 yrs) S/O- Late Dukhu Bauri of Mohanpur, Santuri, Dist-Purulia do hereby lodge a written complaint against them to the effect that today 14.09.2020 while I along with C/702 Anal Kanti Banerjee & C/863 Rupchand Pauria of Santuri as per direction engaged in mobile duty within Santuri PS area, (Reference Santuri P.S G.D.E 524 dtd. 14.09.2020 vide C.C. No. 3365/20 dtd. 14.09.2020) for implementation of Government les regarding Disaster Management Plan. While we were returning from Madhukunda side under santuri P.S jurisdiction and reached at Poradiha Morh through Sarbari – Saltora road at 16:00 hrs. bund that the above noted 02 (two) persons were gossiping without maintaining norms of COVIDas well as without wearing a mask and maintaining social distancing which violates the compliance of norms of wearing of mask and maintaining social distancing during this pandemic muation in c/w COVID-19. So, there is every reason to believe that the above noted persons were boving without wearing a mask and maintaining social distancing which violates the compliance of forms of wearing of mask during this pandemic situation and committed negligent act likely to arread infection of diseases dangerous to life and violated Government rule. So, I have arrested them maintaining all legal formalities as well as notifying the ground of arrest and informed their family members through local people.

Therefore, I pray a specific case may kindly be started against accused (1) Pintu Bauri Byrs) S/O- Dulal Bauri of Mohanpur, PS- Santuri, Dist- Purulia, (2) Biswajit Bauri @ Bishu (36 S/O- Late Dukhu Bauri of Mohanpur, PS- Santuri, Dist- Purulia under proper section of law as disobeyed/ignored Govt. order and committed negligent Act likely to spread infection of the sases dangerous to life and violated Government rule and arrange for its investigation.
