

In producing herewith the following arrested accused persons namely (i) Umesh Chowdhury @ Subha (24 Yrs.) S/O Naga Chowdhury of vill- Kalitala Chardiya, P.O- Kalitala, P.S- Baharampur, Dist-Murshidabad, (ii) Krishna Chowdhury @ Sadhu (22 Yrs.) S/O Sankar Chowdhury of vill- Kalitala Chardiya, P.O-Kalitala. P.S- Baharampur, Dist- Murshidabad, (iii) Majed Sai (34 Yrs.) S/O Munir Sai of vill- Mahal Basti, P.O- Mahal, P.S- Chandankiyari, Dist- Bokaro, State- Jharkhand (iv) Samsuddin Sai (40 Yrs.) S/O Lt. Najir Sai of vill- Mahal Basti, P.O- Mahal, P.S- Chandankiyari, Dist- Bokaro, State-Jharkhand and (v) Abdul Sai (42 Yrs.) S/O Lt. Noor Mahammad Sai of vill- Mahal Basti, P.O- Mahal, P.S- Chandankiyari, Dist- Bokaro, State- Jharkhand along with seized articles i.e, four pieces different size of ring range, one piece big size flat range ,two "Bhojali", one "Tangi", one hacksaw with ten(10) pieces blade, one screen touch white coloured "OPPO" Mobile phone set and one blue coloured "Samsung Duos" keypad mobile phone set. I beg to state that on 12/09/2020 at about 00:15 hrs. I received a telephonic information from my source that 07/08 criminals assembled inside the boundary of Ms. Sunrise Steel & Alloys Ltd., Tata road ,Tamna, Purulia (W.B) with a view to commit Dacoity of costly alloys as copper, iron and other metals from the said abandoned factory. After getting the said information, I informed the matter to O/C Tamna PS over phone and as per his direction I, ASI- Sudip Mukhopadhyay along with C/111 Samulal Tudu, C/877 Basudev Mahato, JC/1539 Nimai Mahato and JC/349 Apurba Pratihar proceeded towards Ms. Sunrise Steel & Alloys Factory to work out the said information with Govt. Vehicles No. WB 56C- 5423 and Tamna P.S. C.C No- 444/20 Dated-11/09/2020. After reaching near the said Factory and proceeded towards inside of the boundary of Ms. Sunrise Steel & Alloys Ltd. Factory on foot at about 00:45 hrs. as per source information, and found 07/08 persons were sitting inside of the boundary of Ms. Sunrise Steel & Alloys Ltd. in a dark place and whispering with each and others. We cordoned them but seeing the Police party they try to fled away. With a hot chase, we able to apprehend the above noted 05 accused persons out of 07/08 persons, on immediate search on their persons (i) One Iron made "Bhojali" with handle length approx 13" from the right hand grip and one blue coloured "Samsung Duos" keypad mobile phone set from the left pocket of pant of Umesh Chowdhury @ Subha (ii) One Iron made "Bhojali" with handle length approx 16" from the right hand grip and one screen touch white coloured "OPPO" mobile phone set from the right pocket of pant of Krishna Chowdhury @ Sadhu (iii) One Iron made "Tangi" length approx 10" with bamboo handle length Approx 40" recovered from the right hand grip of Samsuddin Sai (iv) Four pieces different size of ring range (big and small) from the both hand grip of Majed Sai and (v) One hacksaw with ten (10) pieces blade from the left hand grip and one piece big size flat range from the right hand grip of Abdul Sai have been recovered and seized after preparing proper seizure list duly signed by the witnesses as well as accused persons. On interrogation they stated that all were assembled there to commit dacoity of costly alloys as copper, iron and other metals from the said abandoned factory. Then I, ASI Sudip Mukhopadhayay arrested the above noted 05 (five) accused persons one by one after issued proper memo of arrest and brought them to PS along with seized articles.

So, I therefore lodged complaint against the accused persons namely (i) Umesh Chowdhury @ Subha (24 Yrs.) S/O Naga Chowdhury of vill- Kalitala Chardiya, P.O- Kalitala, P.S- Baharampur, Dist-Murshidabad, (ii) Krishna Chowdhury @ Sadhu (22 Yrs.) S/O Sankar Chowdhury of vill- Kalitala Chardiya, P.O-Kalitala. P.S- Baharampur, Dist- Murshidabad, (iii) Majed Sai (34 Yrs.) S/O Munir Sai of vill- Mahal Basti, P.O- Mahal, P.S- Chandankiyari, Dist- Bokaro, State- Jharkhand, (iv) Samsuddin Sai (40 Yrs.) S/O Lt. Najir Sai of vill- Mahal Basti, P.O- Mahal, P.S- Chandankiyari, Dist- Bokaro, State- Jharkhand, (v) Abdul Sai (42 Yrs.) S/O Lt. Noor Mahammad Sai of Mahal Basti, P.O- Mahal, P.S- Chandankiyari, Dist- Bokaro, State- Jharkhand as per law and arrange to its investigation.
