

Sir.

In producing herewith one arrested accd. person namely Shibaram Mahato (50 yrs) s/o Lt. Lalu Mahato of Vill-Bansradih, PO- Chitora, PS- Tamna, District - Purulia with seizure list and seized articles, I beg to submit that today (12.09.2020) at 17:15 hrs. during evening mobile duty, acting of secret source information and as per order of O/C Tamna PS, I ASI Badal Paramanik along with force had been to Chitora more under Tamna PS at 17:45 hrs. and as per indication conducted raid in the house of Shibaram Mahato (50 yrs) s/o Lt. Lalu Mahato at Chitora more (Permanent Address Vill- Bansradih, PO- Chitora, PS- Tamna, District - Purulia) under Tamna PS and found 2/3 persons fled away from his house and detained one person. On asking his identity he disclosed his name and address as noted above. On interrogation he confessed his guilt for selling and possession of country spirit styled as DILKHUSH. On demand he failed to produce any valid document in respect of selling of said country spirit at his house. As such I seized 23 Sealed bottles of Country Spirit styled as DILKHUSH each Bottle contains 600 ml, 27 Sealed bottles of Country Spirit styled as DILKHUSH each Bottle contains 300 ml, 10 Sealed bottles of Country Spirit styled as DILKHUSH each Bottle contains 375 ml, 05 empty bottles of DILKHUSH, 03 Pieces Empty plastic glass. 01 bottle taken from the each Country Spirit styled as DILKHUSH of 600 ml, 300 ml and 375 ml as sample under proper seizure list in presence of witnesses and signed by witnesses and accused person. Arrested the above noted accused person after observing all legal formalities regarding arrest. Informed him the ground of his arrest. The seized articles were properly sealed and labeled in presence of witnesses duly signed by them and accused person.

The above noted arrested accused person namely Shibaram Mahato (50 yrs) s/o Lt. Lalu Mahato of Vill- Bansradih, PO- Chitora, PS- Tamna, District – Purulia committed offence u/s 46 A (c) B.E.Act, 1909 for unauthorized possession and sales of country spirit (DILKHUSH) from his house.

Under the fact and circumstance kindly take necessary lawful action against Shibaram Mahato (50 yrs) s/o Lt. Lalu Mahato of Vill- Bansradih, PO- Chitora, PS- Tamna, District – Purulia.
