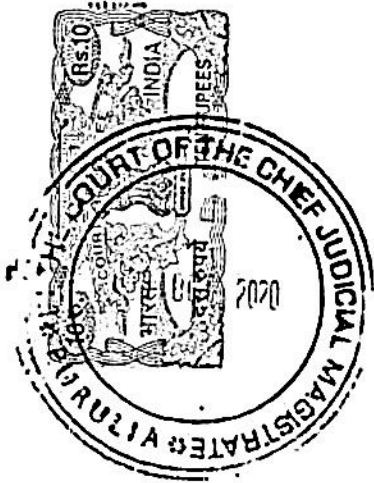

1. That the Complainant has his residential house at Mouza Satra, within P.S. Arsha and within the jurisdiction of this Court and the complainant and his family members are residing therein. The complainant has surrounded his land by raising boundary wall.

2. That on the date of occurrence the accused persons by forming an unlawful assembly armed with ~~Sawal~~, ~~Axe~~, <sup>Lathi</sup> Axe, Iron Rod /n their hands entered into the house of the complainant without any reason and the accused persons damaged some portion of Eastern Boundary wall and some bricks are lying therein. At the time of damaging the boundary the complainant raised objection but the accused persons became furious and began to assault the complainant by fists and blows and Lathi on the mouth and leg of the complainant. Due to such assault the complainant began to throwing hulla and by hearing the same the witnesses came to the spot along with some villagers who saw the occurrence. Prior to assault the accused persons throwing vulgar language to the family members of the complainant and they also gave out that they will murder the family members of the complainant at any point of time.

3. That due to such incidents the complainant has sustained a loss of a sum of Rs. 7,000/- (Rupees seven thousand) only.
