Jagannath Murmu of Vill- Saharjuri, PS-Baghmundi, Dist-Purulia to the effect that on 12.10.2020 while I SI Snehasish Mondal along with force 1) C/22 Chandidas Mudi and 2) C/779 Sudarshan Kuiry both of SAP 11<sup>th</sup> Bn. camp at Baghmundi PS, Dist-Purulia were performing mobile duty vide Baghmundi PS GDE No- 528, Dated- 12/10/2020.
