Sir,

In producing herewith one Dilip Mahato (45 Yrs), S/O-Lt-Kolebar Mahato of Vill-Kundatar, PS-Baghmundi, Dist-Purulia to the effect that on 09.10.2020 while I SI Biswajit Banerjee along with force 1) C/436 Kirtan Mudi and 2) C/317 Hemanta Kr. Sing both of SAP 11th Bn. camp at Baghmundi PS, Dist-Purulia were performing mobile duty vide Baghmundi PS GDE No- 386, Dated- 09/10/2020. During my mobile duty when myself along with force reached at Dava More at 18:45 hrs and found above persons were roaming aimlessly at Dava More without mask or its alternative. I detained him. On being asked the above noted person disclosed his identity but could not able to give any satisfactory answer for that movement on road and public place.

As the pandemic period related to COVID-19 is going on and hence to prevent its mass spreading the Central Govt. & State Govt. has passed order to wear mask in the public place mandatory and ordered to prosecute the defaulters. The order of West Bengal Govt is order no 382-1.S.S./2M-24/2020 Dtd 02.07.2020.

As such the above person violated the order during this pandemic situation duly promulgated by Govt. of West Bengal hence the detained person is refuses to comply the direction given by the Central Govt. & State Govt. to combat the severity of COVID-19 pandemic after several request.

Hence I pray before you to start a specific case against the above noted person under proper section of law.
