Sir,

I beg to draw your kind attention to the fact that:-

1. That I am a member of the governing body of Phoolchand Higher Secondary School Balarampur, (W.B).
2. That one Mr. Swapan @ Badal Chowdhury @ Swapan Kumar Chowdhury s/o late Shyamapada Chowdhury, ^{vill P.S. Balarampur (Kaliola)} is now an employee of central govt. so called Technician, posted at Chittaranjan Locomotive works, Chittaranjan bearing T/No.56/136 in C.L.W as Khalasi w.e.f. 9.11.1996 with his declared requisite qualification passed class VIII certificate issued by Begunkodar High School, Begunkodar, Purulia, now he is with the designation (Tech) grade-1 Fitter which showed that he was born twice i.e. firstly on 2.10.1963 as certified by the Teacher-in-charge of Balarampur Phoolchand Higher School, Rangadih, Balarampur, Purulia (W.B). The 2nd time he was born on 3.1.1970 as certified by the Teacher-in-charge. But the fact remaining that Swapan Chowdhury suppressed that he has passed Madhyamik Examination from Balarampur Phoolchand Higher School in the year 1980 as a regular student being Roll No. Bara No. 172 in 3rd Division as certified by the ~~school~~ school concerned.
3. That Mr. Chowdhury when came to know that the requisite qualification for the appointment of the aforesaid post was only class VIII pass was required then he got admission in class V at Begunkodar High School, after making conspiracy with the then Teacher in charge of Begunkodar High School and the school issued class VIII pass

certificate knowing it fully w.e.f that Chowdhury passed the Madhyamik examination 1980 previously.

4. That thereafter Mr. Chowdhury after suppressing his previous Madhyamik certificate Exam managed to get the above mentioned service and still he has been performing his duties which is a false and forged certificate and cheated all concerned having fully aware that he was intentionally committed the offence against the state and taken undue advantage of it which was abetted by the Begunkodar High School authority/school governing body.

It may be mentioned that he has procured the central govt. service after practising fraud with false date of birth and false class VIII pass certificate and those donot fully with all other certificate including the Admit card etc. It may be mentioned further that Mr. Chowdhury produced one class IV pass ~~maxima~~ certificate before the Begunkodar High School the name of the institution mentioned in the certificate was "Balarampur Kalitala Pry. School" but there is /was no existence of the school at all and he procured a false and a forged certificate in collusion with Begunkodar High School.

So, Sir, I fervently pray that necessary legal step be taken against the above said person.
