



### Most Respectfully Sheweth:

- That the complainant has permanent residence of village Shyamnagar,
   P.O. Supurdih, P.S. Balarampur, Dist. Purulia and accused are also having residence at same village.
- 2. That the complainant have in possession of 2 Acre of land out of 3 Acre and by way of patta in 1991 by Government, the complainant have got his lawful title of 33 decimal in 2014 subsequently. The relevant papers are annexed with this petition.
  - That the schedule property is a agricultural land which is situated at mouza Shyamnagar under Balarampur Police Station, dist. Purulia stands in the name of complainant, the RS, ROR stands in the name of complainant. The complainant is the rightful owner of said schedule property and the complainant possesses the said land with right, title and interest. In the schedule property, the complainant used to maintain some small tree and also planted some valuable plants i.e. Eucalyptus Tree, Sonajhuri Tree etc for firming purpose under Govt. Scheme since last 30 years in the said plot and over such schedule property the accused have no right, title in accordance of law.
- 4. That on 02.09.2020 at about 7 am all the accused persons forcibly entered into the said plot with lathi, iron rod, tangi and kurul in their hands and after breaking the boundary wall with dishonest intention and they illegally and forcibly cut and remove the plants and mature trees in said plot. At the time of incident the complainant and the witnesses witnessed the incident and protested against illegal and high handed activity of the accused persons but the accused persons instead of restrain themselves, continued their illegal act and ultimately they had forcibly taken and stolen away those cutting trees and assaulted the complainant with arm when he raised protest which the accused associated with them. At that point of time when witness no. 3 - Murulidhar Mahato, who happens to be the son of the complainant tried to capture their criminality in mobile camera, the accused persons encompass him along with his father i.e. complainant and started assaulting them by fist and blow and when the present witnesses protested the same, the accused persons left the schedule plot by snatching the said mobile phone from Murulidhar Mahato and Rs. 9000/- from both complainant and his son and at the time of leaving, accused persons threatened the complainant and witnesses with dire consequences.
- 5. That it is matter of fact that the accused persons enter into the complainant's land with dishonest intention in order to grab the property and valuable woods of the trees earthed on that property of the complainant and for which they knowing they have no any right, title and interest over

the schedule property and for causing wrongful loss to complainant and wrongful gain to accused. The accused persons are dangerous and arrogant in nature.

6. That the incident was reported to local police station on the day of incident and after several times but they did not take any legal actions and on coming more threats from the side of the accused persons, the complainant by registered post have brought the matter to local police station on 02.09.2020 but on seeing inactiveness of police agency, the complainant also brought to notice to the Superintendent of Police, Purulia on 08.09.2020 but unfortunately no specific case till started and for which the present complainant having no other alternatives left in hand but compelled to file before your Honour's Court under section 156(3) of Criminal Procedure Code for proper investigation. The police investigation is very much essential as search and seizure are required to be established which police agency can do so as the same has not branded as miscarriage of justice.

That the accused persons have committed various penal offences.

Under the above circumstances it is most respectfully prayed that your Honour may graciously be pleased to send the complaint to concerned police station for causing investigation as contemplated under section 156(3) of Criminal Procedure after treating the same as FIR for interest of justice.
