Today (09.10.2020) myself SI Sanjay Diger along with forces C/458 Debendra nath Mahato, C/1535 Dharanidhar Mondal, C/37 Durjan Murmur to were engaged in mobile duty vide CC No- 4149 /2020 date- 10.10.2020, GDE No- 466 dt- 10.10.2020 and as per direction we were engaged for implementation of Govt. rules regarding COVID-19 Pandemic & disaster management plan. At about 18:25 Hrs, when myself along with force reached at near Chowck Bazar more under Balarampur P.S. we found 03 (three) persons namely 1) Susanta Murmu (19 Yrs) S/O- Lalmohon Murmu of Baradih, P.O- Supurdih, P.S- Barabazar, Dist- Purulia 2) Jaharlal Mondal(35 Yrs) S/O- Lt. Binod Mandal of Sindri village, P.S- Balarampur, Dist.- Purulia 3. Karna Kumar (23 yrs) S/O Subhas Kumar of Village - Bansgarh, P.S - Balarampur Dist - Purulia without having mask were moving aimlessly, so we aware them about the wear of mask and returned them back after giving warning regarding violation of the order duly promulgated by Govt. of India and Govt. of West Bengal in view of COVID -19 Pandemic, but after half an hour later around 18:55 hrs 2<sup>nd</sup> time said 03 (three) persons again without having mask tried to pass through our Police checking point at near Bansgarh Hospital more and making chaos with the Police party so finding no alternatives we arrested the above noted 03 (three) persons after observing all formalities regarding arrest and there is every reason to believe that above noted 03 (three) persons came out from their home without having mask after avoid warning regarding wear of mask and moving aimlessly, in view of Pandemic of COIVD-19 outbreak vide Govt. of India consolidated order No-40-3/2020-DM-1 (A) Date-24/03/2020 and further modified dated-25/03/2020, 27/03/2020, 02/04/2020, 03/04/2020 and 10/04/2020 for complete restriction measure. As such the above persons violated the order during this pandemic situation duly promulgated by Govt. of West Bengal vide Order No- 272-CS/2020 dated 30.06.2020 Therefore they disobeyed Govt. order and committed negligent act likely to spread infection of diseases dangerous to life.

Under the above circumstances, I pray that a cognizable case may kindly be started against 03 (three) persons with proper Section of Law namely 1) Susanta Murmu (19 Yrs) S/O- Lalmohon Murmu of Baradih, P.O- Supurdih, P.S- Barabazar, Dist- Purulia 2) Jaharlal Mondal(35 Yrs) S/O- Lt. Binod Mandal of Sindri village, P.S- Balarampur, Dist.- Purulia 3. Karna Kumar (23 yrs) S/O Subhas Kumar of Village -Bansgarh, P.S - Balarampur Dist - Purulia .
