

Today (11.10.2020) myself PSI Biswajit Chatterjee along with forces C/144 Shaktipada Murmu, C/266 Aman Kumar to were engaged in mobile duty vide CC No-4161/2020 date- 11.10.2020, GDE No- 504 dt- 11.10.2020 and as per direction we were engaged for implementation of Govt. rules regarding COVID-19 Pandemic & disaster management plan. At about 15:25 Hrs, when myself along with force reached at near Dutta Jewelers under Balarampur P.S. we found 04 (four) persons namely 1) Debabrata Chatterjee (33 yrs) S/O- Lt. Anup Chatterjee, 2) Bharat Pal (36 yrs) S/O- Ashok Pal, 3) Prafulla De (50 yrs) S/O- Lt. Nilanbaran De, 4) Dayamoy Dutta (45 yrs) S/O- Lt. Biswanath Dutta all of Vill-Rangadih, P.S - Balarampur Dist - Purulia without having mask were moving aimlessly, so we aware them about the wear of mask and returned them back after giving warning regarding violation of the order duly promulgated by Govt. of India and Govt. of West Bengal in view of COVID -19 Pandemic, but after half an hour later around 15:55 hrs 2nd time said 04 (four) persons again without having mask tried to pass through our Police checking point at near Dutta Jewelers and making chaos with the Police party so finding no alternatives we arrested the above noted 04 (four) persons after observing all formalities regarding arrest and there is every reason to believe that above noted 04 (four) persons came out from their home without having mask after avoid warning regarding wear of mask and moving aimlessly, in view of Pandemic of COVID-19 outbreak vide Govt. of India consolidated order No-40-3/2020-DM-1 (A) Date-24/03/2020 and further modified dated- 25/03/2020, 27/03/2020, 02/04/2020, 03/04/2020 and 10/04/2020 for complete restriction measure. As such the above persons violated the order during this pandemic situation duly promulgated by Govt. of West Bengal vide Order No- 272-CS/2020 dated 30.06.2020 Therefore they disobeyed Govt. order and committed negligent act likely to spread infection of diseases dangerous to life.

Under the above circumstances, I pray that a cognizable case may kindly be started against 04 (four) persons with proper Section of Law namely 1) Debabrata Chatterjee (33 yrs) S/O- Lt. Anup Chatterjee, 2) Bharat Pal (36 yrs) S/O- Ashok Pal, 3) Prafulla De (50 yrs) S/O- Lt. Nilanbaran De, 4) Dayamoy Dutta (45 yrs) S/O- Lt. Biswanath Dutta all of Vill-Rangadih, P.S - Balarampur Dist - Purulia.
