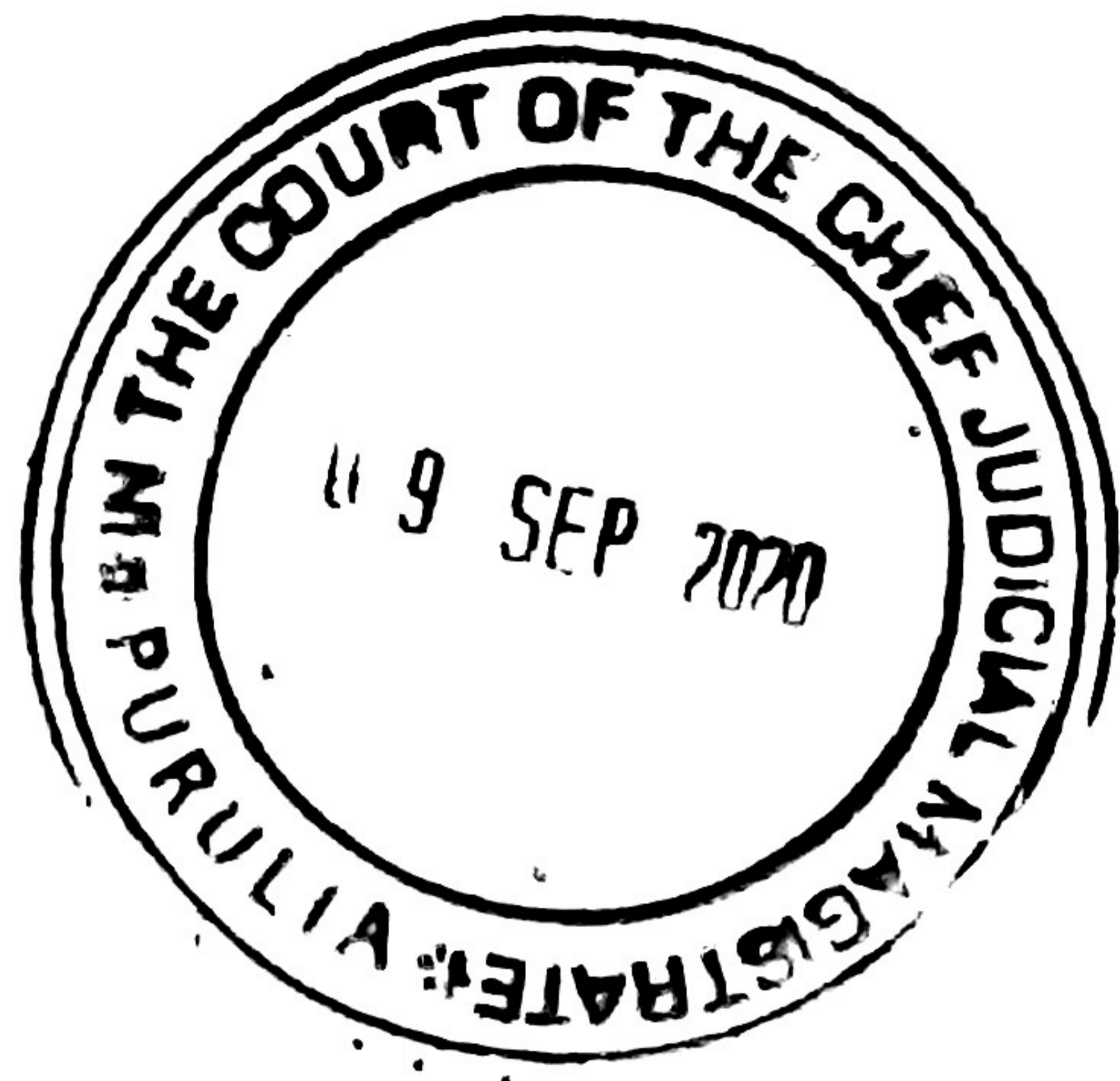

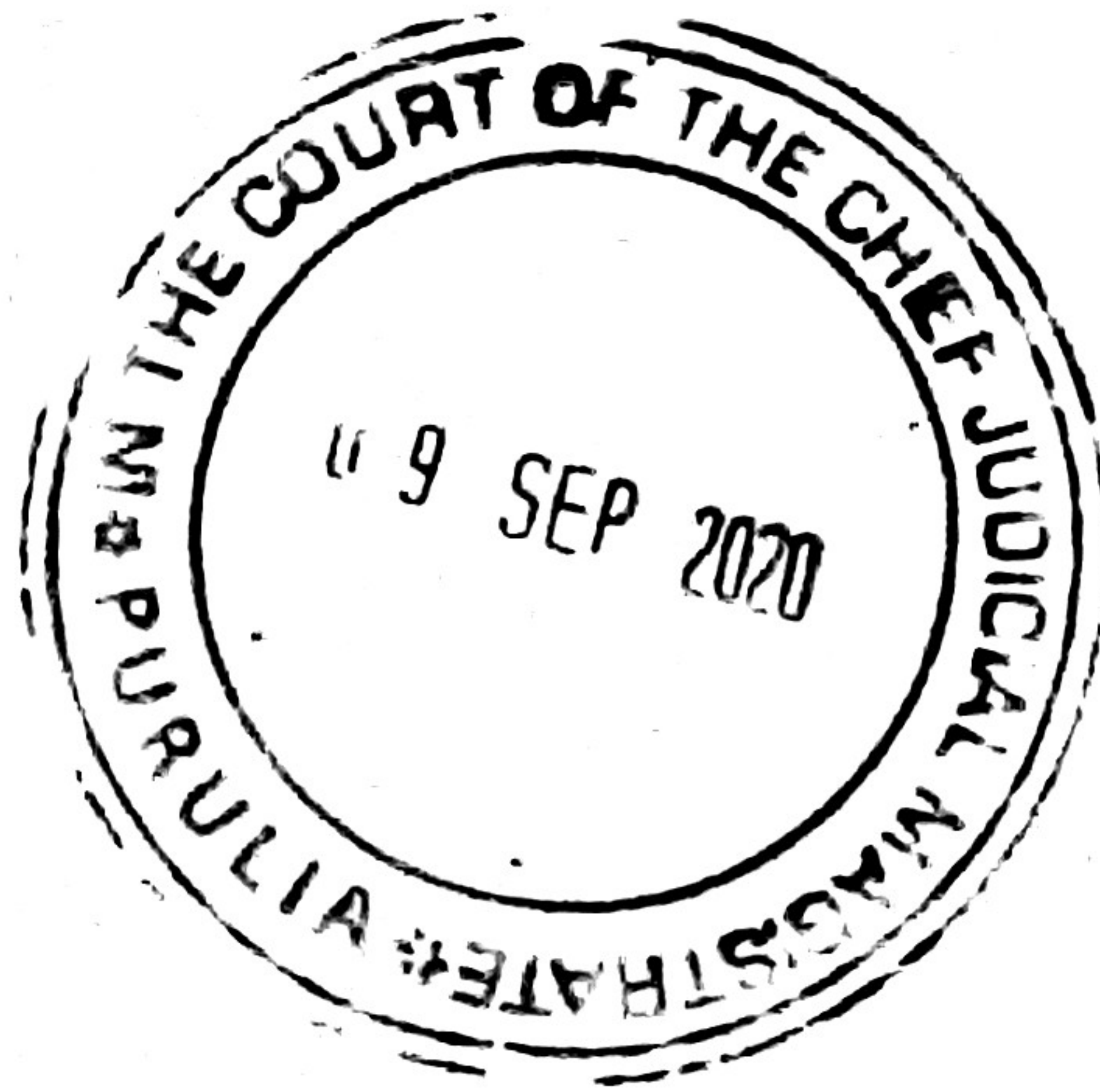

acquainted with each other since long. The accuseds have also visiting term with the complainant.

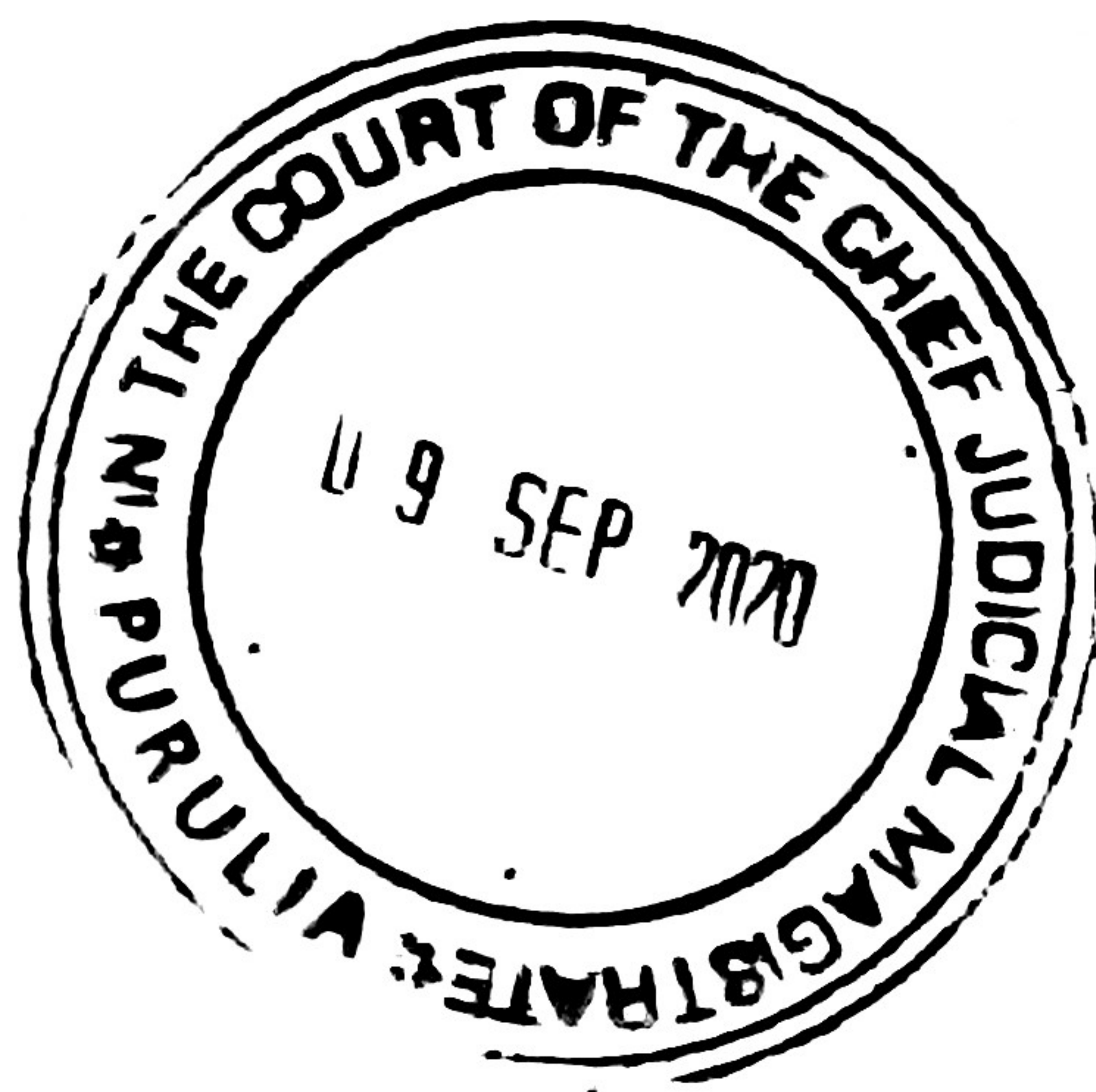
3. That on the date of incident i.e. on 10-08-2020 at about 11-30 A.M. the complainant went to Baroda Bank of Sindri Branch, P.S.Barabazar, Dist.Purulia for the purpose of withdrawal of money for his own use and occupation and the complainant withdrew money from the said bank and put in a hand bag. That on the said date of incident i.e. on 10-08-2020 the above-named accuseds also had been to Boroda Bank, Sindri Branch.

4. That all of a sudden the above-named accuseds came near to the complainant and in connivance with each other and furtherance of common intention of all of them snatched away the sum of Rs. 15,000/- and a mobile phone and the relevant documents of the two wheeler motor cycle of the complainant from the custody of the complainant and they have committed theft in a broad day light.

5. That while the complainant raised alarm the above-named accused fled-away from the spot and at the same time they threatened the complainant in such a manner that-' if the complainant informed the matter to the I.C.Barabazar P.S.against them then they will kill the complainant'. But inspite of that the complainant informed the matter to the I.C.Barabazar P.S.But the I.C. ~~XXXX~~ Barabazar P.S.did not take any step against the aforesaid accuseds.

6. That having no other alternative the above-named complainant lodged a written complaint to the S.P.Purulia on 17-08-2020 for taking necessary action against the aforesaid accuseds. But uptill now no action has yet been taken by the S.P.Purulia against the aforesaid accuseds.
