Sir,

In producing herewith the arrested accused person namely Arvind Sah @ Guddu (38 Yrs) S/o- Ramesh Kumar Sah of Vill- Barabazar Jaynagarpara, PS- Barabazar, Dist- Purulia, along with Memo of arrest, seizure list & seized articles 18 (Eighteen) packets of Rolex Chocolate (Royal Quality)bomb manufactured by Star enterprise Starts (One Dozen per packet); I beg to submit that on 28.10.2020 as per source information & direction of I.C Barabazar PS; myself along with force had been to Barabazar Jaynagarpara to work out the information regarding selling of fire crackers.

Accordingly, myself along with force namely C/- 357 Gopal Biswas & C/- 1228 Babulal Hansda with Govt. vehicle bearing registration No- WB 24C 0788 reached at Barabazar Joynagarpara at 19.45 hrs and found that one person is selling and dealing with fire crackers (Prohibited articles) and seen the Police party tried to fled away. Somehow we managed to apprehend him and on being asked his identity, he disclosed his identity as Arvind Sah @ Guddu (38 Yrs) S/o- Ramesh Kumar Sah of Vill- Barabazar Jaynagarpara, PS-Barabazar, Dist- Purulla. I asked him to produce valid paper/license in respect of selling/keeping/dealing with fire crackers (prohibited articles). He failed to produce any papers or license and cannot gives any satisfactory answer and confesses his guilt.

Accordingly, I seized 18 (Eighteen) packets of Rolex Chocolate bomb (Royal Quality) manufactured by Starts enterprise (One Dozen per packet). I marked the Alamat as Exhibit- A; from the possession of the above noted accused person. The seizure list was prepared at P.O and duly signed by detained persons and witnesses. After that I arrested him by issuing memo of arrest. Then myself along with force, seized articles and all relevant papers and accused persons left for PS.

On arrival at PS I prepared this letter of complaint and handed over everything to I.C Barabazar through Duty officer for starting a case under proper section of law against the accused persons
